Regarding: GKHE Properties, 19800 Detroit Rd

To Whom It May Concern:

The Board of Zoning and Building Appeals will hold a public hearing on November 20, 2025, at 7:00 pm for

- A variance to install a 4' ornamental fence in the side yard abutting a public street right-of-way, vs fences shall not exceed three (3) feet in height when located in front of a building or in yards abutting a public street right-of-way. Per Section: 1167.13 (3)
- A variance to install a 4' ornamental fence within the parking setback, maintaining the required 5' screening setback for the first 82'. The fence moves 6" off the property line as it goes southwards. Fences that are not located within the required setback areas shall be screened with the following landscape materials, planted not more than five (5) feet from the fence and between the fence and the property line. Per Section: 1167.13 (4)(B)2

Before reaching a decision, the Board will give those in attendance an opportunity to be heard.
