The Board of Zoning and Building Appeals will hold a public hearing on July 9, 2026, at 7:00 pm for:

- A **variance** to construct a new two-story single-family residence with a lot coverage of 38.1% vs the 28% that is permitted. Per Schedule: 1153.05 (3).
- A **variance** to construct a new two-story single-family residence with a corner side setback of 5' vs the required 7' setback as shown on the setback map, City of Rocky River, May 12, 1975. Per Section: 1153.07 (a).
