To Whom It May Concern:

The Board of Zoning and Building Appeals will hold a public hearing on September 10, 2026, at 7:00 pm for:

- A **variance** to install a temporary construction sign 8'-6" from the street vs the 25' that is permitted. Per Section: 1193.09 (g)(1).
- A **variance** to install a temporary construction sign with a maximum area of 32 square feet vs the 6 square feet permitted. Per Section: 1193.09 (g)(2).
- A **variance** to install a temporary construction sign with a maximum height of 9' vs the 3' that is permitted. Per Section: 1193.09 (g)(2).

Before reaching a decision, the Board will give those in attendance an opportunity to be heard.
