- Placement of the sign suggested to be moved to on top of or just under the black band rather than floating them in the middle of the windows; black band may actually be a metal material
- Board would prefer more border around the text (at least 1" space)
- Top line should be name of business, services information should be below name in a smaller font
- Mount banner so background goes from edge to edge of outside windows
- Side windows should revise the sign to be the same signs, positioned the same way, and the business name should be included.

Mrs. Szytec moved to approve the window signage with a reduced font size, the business name included, and banner should extend from end to end of windows in front and on the side of the building. Final signage should be forwarded to board members by Planning Department. Mr. Evans seconded.
