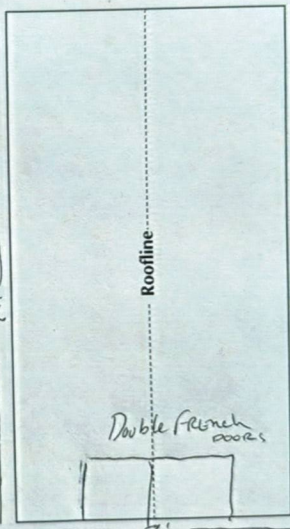

Cancellation, Partial Refund/Restocking Fee: Orders for standard portable building(s) may be cancelled by purchaser if any time before the building is built. If purchaser cancels such an order, Seller will charge the purchaser a restocking fee equal to 25% of the purchase price shown on the first page of this order (The Restocking Fee). Such restocking fee will (1) be retained by Seller if purchaser has paid all of the purchase price or a portion of the purchase price equaling, or exceeding 25% of the purchase price at the time of cancellation, provided that Seller will refund to purchaser all amounts in excess of the Restocking Fee, or (2) be immediately due and owing by purchaser to Seller at the time of cancellation, provided that Seller will refund to purchaser all amounts in excess of the Restocking Fee any amounts then 25% of the purchase price, provided that Seller may apply against such Restocking Fee any amounts then paid by purchaser. Order for custom built or custom painted portable building(s) may not be cancelled except with prior written consent of the Seller, which consent may withhold for any reason or no reason. The remaining balance of the 25% restocking fee, assuming the full amount was not yet collected at time of sale, must be made in order for a cancellation of the contract to occur. Additionally, once the custom and contracted building has been built, Steel City Sheds reserves the right to advise the cancellation process and the purchaser is responsible for payment in full. Additionally, ALL REFUNDING GIVEN will require 3-5 weeks processing time of other requirements are met.
