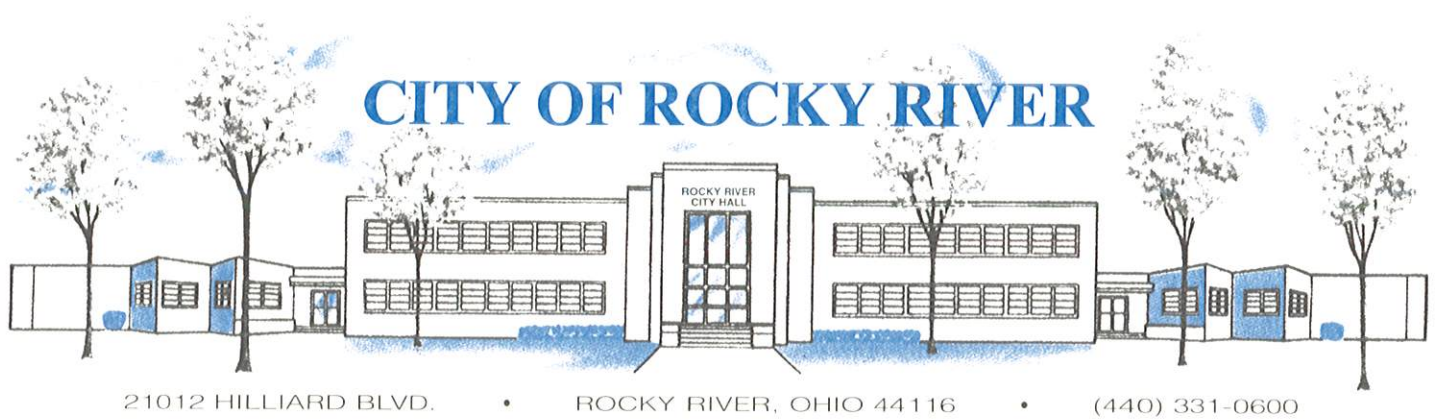




Rocky River Community Improvement Corporation
