MAYOR'S REPORT:

The Mayor announced that the Winter Program Guide for the Recreation Department has been mailed out and is also published online. The Mayor reminded Council that there is also registration available online.

The Mayor informed Council that there are four pieces of new legislation at their places and is asking Council to waive the 72-hour notification rule, so this legislation can be placed on this evening's agenda.

The leaf collection last week totaled 191 tons of leaves and on Saturday, 35 tons were picked up on that day alone. The Service Department is working very hard and continues to post on Facebook updates on their location for leaf pick up. The city will give residents advance notice as to when leaf collection on tree lawns will be discontinued. The Refuse Department will always pick up brown bags of leaves anytime during the winter.

Next Monday at 6:00 p.m. the Soil and Water Conservation District will be hosting a session entitled "Green Yards and Healthy Homes". This meeting is about replacing chemicals for the yard and home that are inexpensive, all natural and effective. This meeting will be held at the Civic Center on December 2, 2019.

The Senior Center Accreditation visit went very well last Friday. The city will not know for a couple of weeks if the Senior Center has received this designation from the State. There was a lot of documentation and the Accreditation Team was very pleased with the Center, the staff, the volunteers, the facility, the programming, the outreach etc. The evaluators were very interested in how our center is funded as they are mainly County

programs and provide different services that are funded in different ways. Director Huff, Mayor Bobst and Director Thomas also provided information to the Team.

The Mayor gave a big thank you and a shout out to students from Lutheran West High School who raked out eleven homes for seniors this past weekend. Their effort was very much appreciated by the homeowners.

The Mayor respectfully requested an Executive Session this evening under Article X, Section VI, Subsection III and IV to discuss a pending litigation matter and collective bargaining matter.

The Mayor wished everyone a Happy Thanksgiving.

- Councilman Hunt asked that since the city has purchased new equipment to assist with leaf pick up, will the city offer to pick up leaves in the spring. The Mayor said yes, that will not be a problem. Mr. Hunt said the Service Department has been very efficient picking up leaves this fall. The Mayor stated that the system Commissioner Snyder has initiated has been a very efficient process.

LAW DIRECTOR'S REPORT: Law Director Bemer reported that he attended a Civil Service Commission Meeting this morning. The Commission certified an eligibility list for promotion to Lieutenant of three Sergeants. There is an anticipated vacancy in the Lieutenant position coming the first of the year.

The 700 Lake Road Project is scheduled for a Public Hearing on December 11, 2019 at 7:00 p.m. There is also a Planning Commission Meeting on December 4th.

Regarding Ordinance No. 78-19 an inquiry was made regarding the proper name for the vendor James Diaz. He is a sole proprietorship and he is also identified as a DBA James Diaz Farms. His name as an individual is consistent with the city's records.

Mr. Klym stated that Council received a revised resolution that changed the verbiage to ratification of filing the grant as opposed to the approval as it needs to be submitted by December 13th. This is a Coastal Management Assistance Grant in the amount of \$100,000 to remove and reconstruct a bridge over Spencer Creek. Mr. Klym will follow up on the questions he raised last week regarding estimated costs of replacing the bridge and whether it requires approval from the State and the Army Corps of Engineers.

ORDINANCE NO. 97-19

ON HOLD

Mr. Hunt has not received any information regarding this ordinance. Section 331.38 currently mirrors the State Code with regard to issues of stopping for a school bus and discharging children. The proposed language would make this a first-degree misdemeanor, which would criminalize a traffic offense up to 180 days of jail and double the fine from \$500 to \$1,000. Mr. Hunt would like to discuss this with Law Director Bemer to get more information regarding this ordinance before it is read for the first time.

- Mr. O'Donnell had a similar question regarding it being a first-degree misdemeanor.
- Mr. Klym discussed this with Mr. Bemer a couple of weeks ago. Other cities are doing this and there was a recent incident that could not be charged perfectly under the city's statutes. There is a House Bill that will increase fines and increase the license suspension times. It also includes differences in the way reckless operation under the state code can be charged and the use of video evidence.
- Mr. Shepherd asked what level misdemeanor this violation is currently. Mr. Bemer responded minor.
- Mr. Hunt stated that as the Code reads the Class 7 License Suspension is up to a year, which mirrors State Code.

Mr. Shepherd said that this authorizes the Mayor to enter into a two-year contract with Mackay Engineering. Mackay Engineering has served the city well and has a lot of institutional knowledge. Mr. Shepherd said the rates are reasonable with slight cost of living increases. This will be discussed further at next week's meeting.

- Mr. Sindelar asked if the city compares this contract with other engineering firms. The Mayor stated the administration sees the hourly rates of a number of engineering firms so there is always opportunity to compare costs. The city is in mid-stream with many projects and the city is very happy with the work of Mackay Engineering. Mr. Mackay would be happy to attend a Council Meeting. These costs are very competitive.
- Mr. O'Donnell stated that the reason engineering contract is not bid is it is a Professional Service and does not need to be publicly bid. There is also a thirty-day termination provision if ever needed.
