MAYOR'S REPORT:

The Mayor extended a thank you to all the volunteers who were involved in the Fall Art Festival, on Saturday, September 17th. The weather didn't cooperate totally, but many artists still participated with many residents attending.

Habitat for Humanity also had a collection on Saturday, September 17th. Several donors donated along with several pick-ups that were scheduled collecting three new appliances. Habitat of Humanity is very impressed with the generosity of the residents of Rocky River. Habitat of Humanity will use the donations in their restore or the donations will be used in projects.

The Mayor also thanked Director Costello and Law Director Bemer for helping with the Shredding Event that was also held on Saturday, September 17th. The shredding event was a success.

The Mayor reported that budgets were due today from the city's directors. The Mayor and Director Thomas will begin work tomorrow and continue working on the budget through the month of October. The Mayor will be meeting with all the directors and will discuss all the Capital Projects and Capital Expenditures. The Mayor and Director Thomas will be prepared to present Council with the budget at the beginning of November. The Mayor applauded the directors for submitting their budgets on time.

Two Ohio Public Works applications were submitted. One application was for Spencer Road and the other for a number of capital projects at the Waste Water Treatment Plant. The Spencer project is a 2.2 million dollar project. The city has reached out to the County and hopefully the County will help with some of the expense. Ten percent of the project will be paid for with local funds totaling about \$224,000 along with a grant request and a zero interest loan request combination for this project also. Council will receive legislation for each of these applications. This will be a parallel process as the District One Public Works Integrating Committee is reviewing all of the applications. This is a very competitive process in Cuyahoga County. The city should know in December whether these projects have been funded.

The Mayor shared with Council a new door hanger that will be used by the Property Maintenance Inspectors from the Building Department. The Inspectors look for several things including: grass that needs mowed, weeds, peeling paint, broken or uneven sidewalks, accumulation of wastes and open storage of items that shouldn't be stored outside, etc. The inspectors will fill the door hangers out and leave them on residents' door handles. The duplicate door hanger will then be entered into a spread sheet that will allow the inspectors to carry out follow up inspections. Residents will also know when they need to respond by along with whom they need to respond to from the information on the door hangers.

This Friday the Senior Center will be hosting a Housing Fair for seniors. Speakers will be speaking on Senior Housing Options, Options for Veterans and How to Plan, etc. Director Huff said that there will also be another Fair that focuses on living independently and the resources available for someone who wants to stay in their home and live independently. The Fair this Friday is open to all seniors in the entire region.

The November ballot will have one Rocky River issue that only concerns Precinct 3D. It is for a Sunday liquor sale at Whole Foods. Whole Foods already holds a D-6 Liquor License, but to obtain a license for Sunday sales, the issue needs to go on the ballot.

The Mayor presented to Council this evening a resolution acknowledging the efforts of Emil Rosol and making a designation to honor his service to the community. This will be a very special surprise for Emil Rosol, who has been a part of many family celebrations, traditions and gatherings at the Civic Center.

PUBLIC COMMENT - LEGISLATIVE ITEMS:

Mr. John Carney, 20664 Beach Cliff Blvd. and Mr. Andrew Brickman, Amended Ordinance No. 26-16: Mr. Carney said that they listened carefully to Council members and have a revised site plan and information to address the concerns raised. Mr. Carney said that they added a provision stating that there will never be more than 40 units and that the sizes will range from 1,500 square feet to 5,000 square feet. In paragraph 3E of the Development Agreement they added a paragraph on landscaping and with no variances required. Exhibit A shows the relation of the building to the joint property owners and also shows the setbacks, the profile and the height of the sustained buildings that are currently on the site and where they sit. Mr. Carney said that he has sent Council a number of articles and a summary of single floor living and why it is important. David Hart said that this request complies with the City's Master Plan and complies with the requirements of Section 1135.21. Mr. Brickman showed Council a rendering of the front of the building from Lake Road. Mr. Brickman said that the parking is on the first level and the building is in steps. The fourth story does not show from Lake Road. The building has also been narrowed down and fits within the setbacks of 30 feet. Mr. Brickman said that this is still a work in progress but feels it will be a great addition. Mr. Carney hopes to give Council a full presentation next week at the Committee-of-the-Whole Meeting.

• Mr. Furry asked if this rendering is still in compliance with the first draft received. Mr. Carney said that they had received questions from Council on what the exterior of the building look like. The height of this building and the set back is how it is shown on the September 16th site plans.

Mr. Carney said that the units facing south will have balconies off the units. The Mayor asked for east and west renderings. Mr. Carney and Mr. Brickman said they would try to get renderings of the east and west side.

• Mr. O'Donnell asked for an explanation on a particular picture. Mr. O'Donnell asked if someone just dropped the building in where it would be built. Mr. Brickman explained that it is dropped in from Google Earth.

Mrs. Mary Wood, 22740 Lake Road, Amended Ordinance No. 26-16: Mrs. Wood distributed more information for Council to read. Mrs. Wood objects to the statement of Mr. Carney and Mr. Brickman that these homes are badly damaged and deteriorated buildings.

Mrs. B.J. Alexander, 22658 Breezevale Cove, Amended Ordinance No. 26-16: Mrs. Alexander stated that the roof top entertainment area concerns her on the proposed building. Mrs. Alexander hears the noise from the Beach House balconies on the top floor and she is worried about the noise level she will hear from the proposed building. Mrs. Alexander also objects to the statement of the badly damaged and deteriorated buildings. She said they became that way after the purchase and were neglected. She feels that putting a contemporary building between "cape cod" type homes will be the beginning of more buildings to be built on other areas of Lake Road. She does not think this building will fit into the architecture of the neighborhood.

Ordinance No. 77-15 is the budget for 2016. This budget is always completed before the yearend. There are occasions however where supplemental appropriations need to be made. Some of the major changes are Gardiner Trane who is working on energy improvements for the city facilities and needs \$695,000 to be moved into the Capital Improvement Fund, purchasing of bullet proof vests, funds for wages for casual labor, schedule parking garage lease payments, revised estimate for a third-party-administrator services paid to Medical Mutual and the Recreation Director needs some additional funds for potential repairs. In addition, there is a need for \$19,000 for Recreation Funds and an additional request of \$29,000 from Chief Stillman for additional equipment and \$2,000 for overtime for the Senior Center.

The General Fund is at 6.3 mills and the other activities are at 10.8. Last year it was at 10.9 and the difference is the Bond Retirement of .9 mills. This has to do with the amount of taxes that is generated from property taxes. The other mills are the Senior Center, Refuse and Recycling and Recreation, which have all been voted on in the past and continue to stay at .5, 1.0 and .5.
