AMENDED ORDINANCE NO. 76-24

Mr. Furry said this has been discussed several times and during the Finance Meeting last Friday. This cannot be passed until the proposed passage of Ordinance Nos. 97-24 and 98-24, which reflects the CBA changes. This will be discussed further next week.

ORDINANCE NO. 86-24

Mrs. Morris said this is a yearly ordinance for grit and screening removal to a municipal landfill for the WWTP. Kimble was the company used last year and they were the only bid this year at a price increase of 12%. The total per year is generally \$35,000 so expect a \$3,500 increase. This will be on a consent agenda.

ORDINANCE NO. 87-24

A CHANGE TO ORDINANCE 915.03(C)(3) AMENDING PRETREATMENT ENFORCEMENT LANGUAGE AND LOCAL DISCHARGE LIMITATIONS

Mrs. Morris said there is a language change in Ordinance 915.03 (c)(3) amending the pretreatment enforcement language and the discharge limitation. These changes are required by the EPA. The change in regulation occurred in 2017 but it was not properly reflected in the language. All the cities that are included in the WWTP must make these changes. This will be on the consent agenda.

Mr. Furry said that the Public Hearing on this ordinance was held prior to this meeting. There was no further comment. The Budget Meeting for the Finance Committee was last Friday and it was a good chance for everyone to hear what their respective Chairs are doing and see how it all works together.

• Mr. Sindelar said it is great how the City of Rocky River has its budget set for the start of the new year. He appreciates the Directors having a budget going into the year. It is smart, logical, common sense and nice to see. The Mayor thanked Council for supporting the process.

Mr. Sindelar said the next three ordinances are various insurance coverages. The point was made when these were introduced that the consultants suggested not to go out to market before 3-5 years due to the uniqueness of municipal commercial insurance that not a lot of companies do. The same points were gone over by Council when these were introduced and there was not many questions. This applies for all three ordinances. This will be on the consent agenda.

Mr. Hunt discussed a couple of points procedurally before getting into substance on both Ordinance Nos. 92-24 and 98-24. As the Mayor informed Council when negotiations were being completed and we had a tentative approval from both the police patrolmen as well as the Sergeants, Lieutenants and Captains. Council is in somewhat of a time crunch to pass these ordinances and authorize the Mayor to enter into those CBA's. These will be read for the first time this evening and again during the Special Meeting scheduled for next Monday. At that time, Mr. Hunt will seek a rules suspension for both these ordinances. The biggest issue would be the wages, salary components for 2025, 2026 and 2027. The increases would be 3%, 3.5% and 4% incrementally for those three years. There were some other items discussed, but he would like an opportunity to look at the agreement more. Mr. Hunt asked if he could have a redline version of the changes. The Mayor suggested a document with the highlights of the changes. Mr. Hunt acknowledges and appreciates the fact as members we were all present when the changes were discussed. This is just a memorialization of what we heard from the Mayor. He hopes for passage next week.

Mr. Sindelar said this has been discussed for several weeks with little to no discussion. The city has used Medical Mutual and their reputation speaks for itself.

- Mrs. Gallagher asked if an employee does not need the coverage, do employees receive a stipend. The Mayor said no, they do not. There is a spousal rule but not a rule on dependence. There are no contributions to the HSA or the FSA but the out of pocket was reduced on the HSA to make it more desirable. The city does audits for that and audits on other dependent from time to time that turn out positively. The city does not have individuals insuring individuals that should not be insured.
- Mrs. Morris asked if it would become a secondary for the spouse. There is a coordination of benefits so that can happen if the spouse is on the city's coverage.

Mrs. Gallagher said this ordinance is to enter a contract with Millstone Management Group for the 2024 Senior Center restoration and addition in an amount not to exceed \$4,551,889.00. There were six bids received on October 18th and the lowest and best bid was from Millstone. The owner's rep from QCI, the principal architect from CPL and Director Snyder agreed to choose Millstone. The funds will be paid out from the Capital Improvement Building

Account. Six references were interviewed that have worked with Millstone such as Mentor School District, Vision Work, Chardon Schools and Cuyahoga County Landbank. They all recommend Millstone for their attention to detail, quality and excellent communication.

Mr. Furry said Council has vetted these eight ordinances and resolutions over the last month and a half. There has not been a lot of discussion. Mr. Furry moved to approve Amended Ordinance No. 77-24, Amended Ordinance No. 78-24, Ordinance No. 80-24, Ordinance No. 81-24, Resolution No. 82-24, Ordinance No. 84-24 and Ordinance No. 85-24, seconded by Mr. Sindelar

COMMITTEE REPORTS: NONE

COMMUNICATIONS: NONE

PUBLIC COMMENT: Christina Brown, a resident of Rocky River, but also works for the Cuyahoga County Board of Developmental Disabilities. They are going around to all the communities in Cuyahoga County to reintroduce their services to the members to help constituents if you receive phone calls, etc. Their mission is to support and empower people with developmental disabilities to live, learn, work and play in the community. They support more than 14,000 people with developmental disabilities in Cuyahoga County and last year in Rocky River alone served 152 people. Two-thirds of their \$150 million budget comes from a 3.9 continuous levy that was passed by Cuvahoga County voters in 2005. From birth to adulthood, they support people with DD to live their best lives. They provide early intervention, occupational and physical therapy, consultative services to students in the schools, transition services for young adults, housing and employment supports and assistive technology. They have positioned the agency as a leader in the state when it comes to supporting people with developmental disabilities to live, learn, work and play in their communities. They partner with CSU for the RISE Program that aims to give students with disabilities a typical college experience while assuring their support in ways that they can help. We are doing innovative work, housing work in Lakewood. Last year they opened Tiny Homes for people with disabilities. They partner with Youth Services like DCFS, ADAMHS Board, Family and Children's First Council to support youth in crisis. They also helped with the T-Suites Opening. In Rocky River alone, they provided grant money for Elle's Enchanted Forest, given money to Rocky River Public Library for the Reading Program which helps promote a curriculum of inclusion, diversity, kindness and showing people that we are more alike than different. In addition to supporting people with disabilities in Cuyahoga County, they strive to be a resource for the community. We would welcome the opportunity to talk more and how we can help support residents of Rocky River.

The Mayor said that Christina's message is an important one for the Chamber of Commerce as well. The Mayor asked if there is an update on the Adult Developmental Center on Detroit and also do you have job coaching. From time to time, the city has through Opportunities for Ohioans with Disabilities been a center where job coaches and individuals can come to learn skills. The city does everything from interviewing to actual job skills, etc. Are there these opportunities and how would the city access those. The business community would be interested as well.

Ms. Brown said that regarding the Rocky River facility that Cuyahoga County had to get out of direct care services due to a state mandate in 2020. There is a private provider working at the Rocky River facility, "Solutions at Work for People", on a lease through the end of this year. Ms. Brown imagines that if given the opportunity they will continue to provide the services. It is a needed service to have a day program and there are private providers throughout the County that provide it. She is happy to give more information as she receives it. As it relates to OOD and the employment collaborative, they do a lot of work finding people with disabilities a job through a network of resources. All kinds of various employers are part of that. She is happy to give a contact to the Mayor
