MAYOR'S REPORT:

The Mayor began by saying she was happy to present to Council the 2025 Budget Books. A big thank you to Director Thomas as this is the last budget he'll present to Council on behalf of the administration, thank you to Jonathan Lindow who has worked by his side through the process helping him, the other directors and the other staff in the Finance Department. Also, a big thank you to all the Directors who spent a lot of time on their budgets. There have been some adjustments made to this budget as we are committed to a balanced budget. The Mayor said that work continues on the Capital Budget as it is a very aggressive budget. There are a lot of projects that need to be completed that may have funding sources attached to them or part of the EPA findings and orders, so it is continuing to be refined as many of the projects are in phases. As those happen, Council will be updated along with each of their budget books. The cover is a photograph of the antique fire truck that was taken by Chief Lenart. A different photograph although similar to this photo, will be the cover of the Residence Reference this year since the city is building a new Fire Station.

The Mayor discussed pickleball at the Recreation Center. Part of the city's desire is to create safe and enjoyable recreational sports. Director Holub did shut down the pickleball and has spent a great deal of time talking with individuals that are passionate about this sport. The Mayor has received three phone calls and has thanked all the individuals that called as they have appreciated what the city is doing as they want to enjoy this sport. There have been several distractions, disagreements, et cetera. This program was self-governed and now the city is taking a step in having a far greater role with registrations, moderating and a fee that will be attached to pay for the

monitoring. On Thursday, the Parks and Recreation Commission will be meeting and they will receive an outline of the new plan for indoor pickleball and how it will be implemented. Thank you to all the pickleball players who have played a role in sharing constructive ideas with the city on how these programs are implemented in other communities and how they function quite successfully.

The Mayor stated that final paving in the city will happen next week weather permitting.

The Westmoor, Glendale and Orchard Grove bid will be opened on Friday. That is an important one for the city as it contributes to the Magnolia overflow, one of the last two overflows in the city. The city promised the EPA that by 2027 this overflow would be closed. This has been in the budget and will continue to be in the budget.

The Mayor announced that the Citizen's Police Academy will be taking applications shortly with the applications available later this week. The class will begin in early January. The Mayor encourages anyone who is interested to obtain an application and apply.

The Mayor announced that the Business Expo, sponsored by the Rocky River Chamber of Commerce will be this Thursday from 2:00 - 6:00 p.m. at Memorial Hall and in the gymnasium.

The Lake Road Holiday Walk is this Friday evening. This is a very well attended event with Wildflower Bakery and all the shops along Lake Road opening their doors.

The Mayor said that the Deer Management Meeting will be held next Monday afternoon. Information from the meeting will be shared that evening with Council.

Today kicked off a week-long Membership Drive at the Civic Center and it has gone well today ringing in \$56,000. Last year during the one-day Membership Drive, \$146,000 was raised but there were people standing in line. Kudos to Director Holub and his staff for extending the drive for a week.

The Holiday Walk will take place the first Saturday in December. The city is working closely with Old Detroit Road, the Detroit Merchants Association and the Rocky River Chamber of Commerce. There is a drop down on the city website under Recreation that people can follow for all the festivities. There will be a kick-off parade again at 11:00 a.m. which was a big hit last year. There will not be a tree lighting ceremony but there will be a beautiful, festive lighting display at City Hall the Friday after Thanksgiving.

The Mayor highlighted some achievements in the Police Department which speaks to Council passing last year's budget. Last year's budget provided additional dollars for training, education and travel in the police budget. The Mayor reported that two of the officers attended Leadership Training and both have graduated. Sergeant DiMatteo went through the Supervisor Training and Education Program which is the first step in leadership. It is designed for newly promoted officers who will be transitioning into leadership roles. He successfully completed that with his graduation last week. This Friday, Sergeant Rodriguez will have completed his Police Executive Leadership College credentialing. There is one more step and Chief Lichman is certified in C.L.E.E. which is Certified Law Enforcement Executive which is the top step. The Mayor is very happy that two of our sergeants have completed these programs showing Council that those dollars are being invested in leadership and the furtherance of the police department.

The Mayor announced that City Hall will be closed tomorrow in observance of Veteran's Day. Refuse will be delayed one day. The Mayor gave a big thank you to the city's veterans. While their service to the military may have discontinued, their service to the community has not. The veterans are involved in civic organizations, churches and the schools. They have hearts of servants and it shows in the community. Thank you to all our veterans that reside in the community and all the veterans that work for the City of Rocky River as there are many.

The Mayor discussed last week at the City Council Meeting the pressures on families receiving SNAP funds. Meals on Wheels took this very seriously. After the city's ReadyNotify was sent out, Meals on Wheels received 19 new individuals for their program. If the people were homebound, meals would be delivered to them. Meals on Wheels provided all of these meals to SNAP recipients at no charge. Meals on Wheels needed volunteers to help pass out the other meals for those that could drive up and pick them. The Mayor contacted the Senior Center where Director Huff immediately jumped in along with Mary Hildebrandt the Social Worker and now there are a group of volunteers going over to Meals on Wheels to staff it along with city staff members that are taking their lunch hour to go over and be helpful. This hopefully will be short lived, but there is now a mechanism in place should this ever occur again. Meals on Wheels is such a wonderful organization and just celebrated their volunteer recognition luncheon. They do amazing work in the Rocky River and Lakewood communities. A big shout out to them and their leadership along with Director Huff and Mary Hildebrant for bringing it all together.

• Councilwoman Gallagher attended the Quilt Show this weekend and won a raffle prize.

Mr. Shipp explained that the Recreation Department is requesting approval for revised fee schedules effective January 1, 2026, encompassing the Civic Center, Outdoor Municipal Pool, and Ice Rink admission and membership rates, rental fees for Elmwood Cabin, the Rocky River Park Pavilion, and the City Hall Gazebo. These are needed increases. Relating to the facilities, these revised fee schedules would take effect January 1, 2026. These adjustments were developed through an overview of comparable community rates, existing amenities, private-sector competition, and overall increased expenses in operations. In most cases, these rates reflect a rounded 10% increase across all five ordinances. Some exceptions do exist but primarily it is a rough estimate of what the department is looking at. The primary driver of these adjustments are wage expectations as it was two years ago when a similar ordinance was passed. The last time the Civic Center rates were increased for the rentals of the Elmwood Park Cabin, City Hall Park Gazebo was in 2021. The other ordinances were in January of 2024, again due to wage increases and the market. This is still an affordable amenity for the residents. Mr. Shipp has a family of four membership to the rec center and even with the increase in fees that would take effect next year, it is still \$54.00 a month for his family to have access to the rec center gym, the fitness center equipment, the indoor walking track

and all the perks and amenities of the programing and the membership fees that includes. This is a continued adjustment and is needed as the wages and expenses keep going up. This will be added to the consent agenda.

Mrs. Morris said this is a yearly ordinance for sodium hypochlorite, which is a disinfectant for wastewater. This is a new supplier and there was a 12% reduction in price from \$2.13 a gallon to \$1.87. Superintendent Barille feels the new supplier will be able to handle the capacity and the supplier has been vetted. Mrs. Morris has had no questions about this and would like to place this on the consent agenda.

Mr. Hunt said Council has discussed this for a few weeks now. This resolution would authorize the Mayor or presumably Director Snyder to make application to the Cuyahoga County Community Development Supplemental Grant Program to install a mid-block crossing on Rockcliff Drive at the same time as the road and sewer water main work on Rockcliff happens in 2027-2027 construction season. This would connect the all-purpose trail which is presently on Rockcliff hill heading down into the MetroParks, across Rockcliff and then up to Wooster. As this is simply a resolution authorizing the city to apply for grant funds, this will be placed on the consent agenda.

- Mr. Shipp asked if lights would be needed. Mr. Snyder said that if this project is implemented, he would install the mid-block crossing without the RFB's up front and evaluate the safety at that point. If there are continued issues with the safety of pedestrians and cyclists crossing, the city can look to add the lights later. His thought now is based on the traffic usage, speed and the criteria and feels lights are not warranted at this time.
- Mrs. Gallagher commented that she loves the flashing light on Elmwood. Mr. Snyder said the other side will be installed later this week.
- Mr. Shipp thanked Director Snyder for exploring and researching to find a good compromise for everyone.

Mr. Shipp said this resolution needs to be submitted to ODNR by December 14th so with next week's meeting we should be well on track for that. The city would like to apply for a grant to implement recommended improvements that were part of the Master Plan done for the park earlier this year. The improvements include a new restroom, viewing deck, parking lot entrance and an ADA compliant trail from the street level to the playground and pavilion level. The estimated cost is around \$1.6 million and this grant is requesting \$500,000. Mr. Shipp shared photos or a

drawing of the area of the park that would be improved under this plan. Considering there has been little discussion about this, it can be added to the consent agenda.

President Furry said that this is the next step requiring Council approval. Finance Manager Lindow and Finance Director Thomas have been actively working with the financing team consisting of Raymond James and Tim Reidy as underwriter, Blake Beachler of Calfee, Halter & Griswold as Bond Counsel and Municipal Advisors Matt Stuczynski and MAS Financial Advisory and AJ Allen of Davenport & Company, LLC. Mr. Furry questioned why there are two municipal advisors. Mr. Stuczynski of MAS Financial Advisory is known throughout the region for local and directed advisory experience while Mr. Allen of Davenport & Company strength is data needs and analysis. They will be available on November 17th for any additional comments or questions. It should be noted that the BAN or bond anticipation notes can be rolled up to twenty annual periods and the OMAP only applies to the BAN portion, not when it rolls to bonds. This ordinance is the trifecta of Council action of Ordinance 73-25 on the GMP Contract totaling \$14,448,336 and Ordinance 63-25 the Declaration of Intent/Reimbursement as well as the temporary design, housing and owners rep. This authorizes the planned note issuance not to exceed \$12,500,000 which will take place in the first quarter of 2026 but would like to get this done or at least approved in 2025. This is the maximum amount and may be less based on such factors as cash flow, budgeted capital projects, current year end balances and interest rates. The BAN or Bond anticipation note will have a one-year maturity sometime in the first quarter of 2027 and can be extended for additional years. The City's Finance team will continuously review market and financial conditions for the best long-term option. The city also has available a state program known as OMAP or Ohio Market Access Program which was initiated by the State of Ohio after the 2008 financial crisis and has the full faith and backing of the State of Ohio but does not apply to the bond once the city goes to permanent financing. Mr. Furry is expecting two more reads on this ordinance.

Mr. Sindelar had the Clerk read the next three and he will discuss them together as they are companion pieces.

Mr. Sindelar said there are a lot of fine points to this that he will reserve for the next meeting. These come up every now and again and conventional wisdom would say to rebid these contracts. It is different when dealing with commercial liability insurance like this and insurance for employees. The consultants have advised the city not to go out to market as it could hurt the chances of the city getting coverage. The not to exceed amounts listed are the maximum fees for 2026.

• Mrs. Morris assumes that the costs for the Courts and the WWTP are shared with the other entities. Mr. Sindelar concurred.

Mr. Sindelar said he will not go into all the fine points this evening, but this project has been discussed in total all the way back in researching and getting grants to see the feasibility of what changes would assist over here. The city is moving forward with this project. With any great project is the significant amount of funding sources that make this up which is 68% of this project including \$1.5 million from ODOT for Urban Paving, \$360,000 from NOACA for Liveable Communities Initiative Grant Program, \$450,000 from NOACA's Congestion, Mitigation and Air Quality Grant Program, \$196,000 of State Capital Funding from Senator Dolan's office, \$150,000 from the City of Fairview Park totaling approximately \$2.6 million. This is very impressive on top of what this project should and will accomplish.

- Mr. Furry asked if American Structure Point is the Construction Manager or Engineer. Mr. Snyder said they are the engineers for the project. When the city began the design and engineering for this project, the city needed an engineer that had a lot of transportation, signal and electrical controller experience. That was somewhat out of the realm of MacKay Engineering's wheelhouse at that point, so the city sought proposals. It has been a couple of years since American Structure Point's contract was authorized. Mr. Furry thinks these grants should be listed on the Ordinance cover. The Mayor said the cover sheet could be amended to indicate the various grants.
- Mrs. Morris asked to see the plans for Center Ridge. Mr. Snyder will email the plans to the Clerk for distribution.

Mr. Sindelar said this contract is specifically for dental insurance. There is a 10.69% increase which seems high but the city had a two-year rate freeze. Mr. Greco did go out and received a bid from Medical Mutual but this is the lowest and best bid. The Mayor added that single coverage has an increase of .22 cents, employee plus one coverage increases of .41 cents and family coverage increases of .79 cents per pay, which are relatively small increases considering the type of insurance.

President Furry said this is the annual wage ordinance for 2026. Some general items are the state minimum wage increased to \$11.00 an hour. The secretary position for the Charter Review Commission was added which is done every six years with the same salary as 2020. The Civil Service Commission Member increased to \$50.00. a month from \$30.00 a month where it had been for quite a while. The title of Assistant Senior Center Director was added in expectation of the Director's retirement. Police and Service received a 3.5% bump per their contracts and accordingly exempts saw the same as they follow what CBA's receive. Mr. Furry expects this will need to be amended at some point as Fire and WWTP are still in negotiations for their 2026-2028 contracts.
