### **MAYOR'S REPORT:**

The Mayor announced that the Fire Department has made its move and is now located at the Service Garage for the next 12-14 months. The city has notified all the residents in that area. Residents who find their way to the Service Garage should note the markings on the driveway going up to the parking lot. Those are directional arrows so residents do not meet a fire truck coming down the hill that is being dispatched. Please follow the arrows and everyone will be able to traverse the service garage efficiently. The Mayor thanked Chief Lenart for the incredible job of getting the department moved on Wednesday. They were moved and operational on Wednesday. Thank you also to the mutual aid partners who were a big part of the move as well. Congratulations on the wonderful job.

As the Mayor mentioned last week, the asbestos abatement will occur over the next couple of weeks followed by the demolition of the building. Following that, the construction of the new Fire Station will begin.

The Mayor shared the Building Stats so far for 2025:

- In 2025 there have been 1,342 building permits pulled 143 in commercial as compared to 100 this time last year; and 1,199 in residential as compared to 1,249 this time last year.
- The valuation of both surpasses last year at this time with the valuation this year at \$45,155,000 as compared to \$40,646,000 in 2024. Investment continues to be robust in the community, in both commercial and residential.

The Mayor announced that the City of Fairview Park has introduced legislation for deer culling within the city limits of Fairview Park. The City of Rocky River administration is meeting with ODNR's Wildlife Division, at the urging of a couple of residents, along with Director Snyder and the city's Animal Control Officer. We will be meeting with the manager of Human Wildlife Conflict and Interactions to discuss ways the city may be able to manage the deer herd in Rocky River.

The Westlake Hotel celebrated their 100<sup>th</sup> anniversary last Friday. The Mayor complimented Councilwoman Gallagher on a beautiful job Friday night. It was a wonderful event. The Mayor and Councilwoman Gallagher had remarks and the Mayor presented a Proclamation honoring the 100<sup>th</sup> anniversary of the Westlake Hotel on behalf of the administration and City Council. It is an amazing and breathtaking building. Every time the Mayor is there she is amazed at how the building has been honored and cared for. It is a true treasure in the community and has a lot of interesting history.

The Mayor said that the landscaping commenced today at the Senior Center. The Senior Center is really shaping up inside and outside with paving following soon. The Senior Center is on track for opening at the end of November with a formal dedication of the new Senior Center expansions in the spring.

On Monday, October 20<sup>th</sup>, it is skate with the Monster's Hockey Team, which is always a big highlight for the numbers of children in the hockey program.

The Shredding Trucks will be at City Hall Campus this Saturday from 9:00 -11:00 a.m. The administration encourages residents to enter through the Wagar entrance.

The Mayor reported that Commissioner Sam Rosario shared at the Director's meeting this morning, that the first salt delivery was this morning and the barn is full. The city is ready and plows are ready to be attached, which speaks to the level of service the Service Department is always able to provide by being very flexible, nimble and prepared.

• Councilman Sindelar asked if there is a limit on the number of boxes for shredding. The Mayor responded that they try to limit it to two normal size boxes of materials that are placed in the trunk or back seat. Volunteers are there to help remove the boxes from your vehicle.

Mr. Hunt said this ordinance has been discussed since the beginning of September. This ordinance proposes to amend the Codified Ordinances to establish a three-foot prohibition or buffer for parking in front of a public or private driveway. There has not been a specific delineation of an area that is safe for cars to egress and ingress into driveways avoiding parked cars. With the approval of this ordinance, it would establish a three-foot buffer at the apron.

President Furry said the mid-year budget reviews are done in July and this supplemental is a result of that and has both pluses and minuses. The first is a salary in the Mayor's Office. The previous Executive Assistant, Mary Ellen Umerley basically had a time share with both time and expense with the law department and the mayor's office. With the hiring of Michelle Root, that original appropriation changed. The finance changes come from the addition of the finance manager, which precipitated the increase. Parks Division relates to overtime, wages and related pension costs. Chief Lenart would like to be prepared for potential equipment and vehicle repair costs for the remainder of 2025. Regarding the sequence of events for the Bond interest, Council authorized the Bonds in December 2024; on February 27, 2025 Council issued the bonds and now have the known interest amounts. Lastly, there are some meaningful adjustments to certain funds of the Municipal Court as discussed with the court officials. There is a new fund, the Indigent Driver Alcohol Surplus Fund that is authorized by the Ohio Revised Code 4511.191 (H). Because of the provisions of the Ohio Revised Code chapter, there is an interplay between the Courts Indigent Driver Alcohol and the Indigent Driver Alcohol Surplus funds and both need supplemental appropriations.

Mr. Furry moved to amend by substitution of Exhibit A dated 10.13.2025, seconded by Mr. Sindelar and Mr. O'Boyle.

Mr. Furry said that this is the annual true up of the quarterly sewer bills. This could be paid quarterly but it is more fiscally prudent to do it annually although some residents have complained about the true up. This technically does not need Council approval based on the dollar amount, but there may be some waterline project reimbursements later this year, which more than likely would need to be authorized by Council.

**RESOLUTION NO. 62-25** BY: DAVID W. Mr. Furry said he mentioned this in the supplemental appropriations ordinance. This is for the Indigent Drivers' Alcohol Treatment Surplus Fund. There are several regulatory approvals needed to establish a new city fund. Approval action by City Council is one of them. The Indigent Driver Alcohol Treatment Surplus Fund is stipulated in state code under Ohio Revised Code 4511.191 (H). The city also received an administrative order from the municipal court judges. Both the Cuyahoga Budget Commission and the Ohio Auditor of State require action by City Council. On a side note, as mentioned earlier, Councilwoman Gallagher with her inside knowledge forwarded some grant funds available to the municipal court. Thank you again to Mrs. Gallagher.

Mr. Furry said this is more of an administrative action to allow certain city officials permission to complete and file the declarations of official intent to make an expenditure that the city will reimburse with the proceeds of tax-exempt securities. It should be noted that this does not authorize the issuance of any notes or bonds. That must be done separately in another ordinance. This is just laying the groundwork allowing Council to do so.

Mr. Sindelar said this ordinance has been discussed for several weeks along with the litany of services that this provides for a very relatively low investment per resident. From a community standpoint the individual resident has the opportunity for immunizations, flu shots and things of that nature. From a city standpoint, there are environmental services that include water testing, lead poisoning prevention, food protection that are all hot button issues and things that are highly technical and so it is good to have this agreement in place and pay for this service so the city has this resource readily available to go to in an instant when something happens.

Mr. Sindelar said that this has been discussed previously too. This project began in 2017 with the City of Fairview Park to make the Center Ridge area a more liveable community. This will included ADA compliant ramps to signalization crossing boulevards and all things in the name of safety. The city keeps reaching for new technology and changes and grants to study the issues. The study begins and is the basis of the project. How can it be more liveable and walkable. The Mayor added the city did receive a TLCI Planning Grant and this grant is the building of it and actual improvements. The planning has already been completed. Mr. Sindelar said he was referring to the previous grant where the city worked in concert with the City of Fairview Park. Everyone can agree that it was time for a change to bring Center Ridge Road into the 21st Century making it safer and more appealing.

Mr. O'Boyle said that this resolution is like additional resolutions passed last year and one earlier this year. In essence it is asking Council to attest to the fact that the city does not need the land that is being used for submerged purposes. To quote directly from the letter forwarded to Council by Ray Reich, one of the necessary components for revising a lease from the State of Ohio is an ordinance or resolution from the local authority stating that the area of submerged lands in question is not needed by the local authority for future improvements (i.e. breakwaters, harbors, marinas, piers, etc.) and that the land used in any application should comply with the regulation of permissible land use of the local authority. It is based on that, that they are asking Council to attest to the fact that the city does not need the land for those purposes. He will talk to this more at the next meeting.

Mr. Hunt said that this ordinance is for the oversite of the renovation and creation of the new fire station. Infinity is the chosen entity. Council will recall that in July an ordinance was passed entering a contract with Infinity Construction to implement the temporary housing that is now been established at the Service Garage for the temporary housing of the Fire Department during the rehabilitation of the new Fire Station. The contract before, No. 73-25, would authorize the city to enter into a contract again with Infinity to manage the demolition of the existing fire station and the construction of the new station. The guaranteed maximum price includes hard costs or construction costs of nearly \$13 million and indirect costs or soft costs as described in the exhibit in an amount of \$1.5 million totaling \$14,396,170.00 and in speaking with Director Snyder this would be the maximum cost. The trades and subcontractors are all included which is different from the Police Station. Council will recall that each of those were bid out individually. This will allow Infinity to handle all the trade contracts for asphalt, landscaping, fencing, concrete, masonry, structural steel, carpentry, electric, HVAC so it is an all-inclusive oversite for Infinity. Director Snyder apologized for not being in attendance this evening, but he will have additional information in more

detail to share at next week's meeting. This will have three full reads with more opportunities to delve into this deeper if there are any issues.

• President Furry said that looking at some of the cost breakdown, he is going to trust that others have picked it over very well and he will trust their judgement and expertise more so than what he has. Mr. Hunt said exactly and the Director has more detail as to the bids for each of the subcontracts and will share those details with Council.

**COMMITTEE REPORTS: NONE** 

**COMMUNICATIONS:** The Mayor mentioned in the absence of Councilman Shipp that there is a meeting of the Parks and Rec Commission this week and they will be reviewing several increases to fees for the 2026 Budget. Those that are changed or updated will come to City Council.

**PUBLIC COMMENT:** Mr. Genesis Brown, 2794 Goldwood Drive, Good evening. My name is Genesis Brown. My wife Christina Brown is the Chief Operation Officer and we are here representing Cuyahoga County Board of Developmental Disabilities. We are also residents of Rocky River. Last year, we attended Rocky River's City Council meeting to share some updates with you about Cuyahoga DD and give you an overview of the work that Cuyahoga DD does.

This year, I'd like to start by recognizing an important milestone for Cuyahoga DD – the 20th anniversary of our last levy. Two-thirds of Cuyahoga DD's \$150 million budget comes from a 3.9 mil continuous levy that was last passed by Cuyahoga County voters in 2005. From birth through adulthood, Cuyahoga DD supports people with DD to live their best lives. Cuyahoga DD's mission is to support and empower people with developmental disabilities to live, learn, work, and play in the community. Last year, we served 154 people with developmental disabilities in Rocky River, and we served approximately 15,000 people across the county. This is a 20 percent increase in people served compared to 2005.

Over the last 20 years, this levy, approved by Cuyahoga County voters, has supported people with developmental disabilities through:

- · Early intervention services
- · Therapies like occupational and physical therapy, and speech language pathology
- · Consultative services to support students in schools
- · Transition services for young adults
- · Housing and employment supports
- · Assistive technology services

Levy funding also allows Cuyahoga DD to make strategic investments in the community. Since 2021, we have granted nearly \$1 million to support over 50 community libraries, arts and culture, and recreation and leisure

organizations in making their programs and physical spaces accessible to people of all abilities. We awarded \$180,000 in community grants in 2025.

In addition to our work supporting people with disabilities in Cuyahoga County, we strive to be a resource for communities. We would welcome the opportunity to talk more about how we can best support the residents of Rocky River. Thank you for your time.

Ms. Andrea Mediate, 21246 Maplewood Avenue, said that she has been working with the Mayor and Director Snyder to help identify key traffic issues and dangerous crossings and they are starting to see the results of these findings in the various things going up all over the city, which is fantastic. She is from the Rocky River Green Team and also represents Bike Rocky River. On her street alone, it looks like there is a crosswalk going in by Elmwood Park which is amazing. She is also seeing improvements on Wagar Road as well. The speed bumps are going in and high visibility signage. As a response to several accidents and near misses, there was the ReadyNotify that has come out and the video from the Superintendent and SRO's. Since the pandemic, the Traffic Safety Organizations nationally have reported an increase in speeding and light running. In this area, Cleveland and Rocky River, the construction on I 90 is diverting traffic into Rocky River and Lakewood on the streets. She feels that none of these improvements will take the place of an officer in a patrol car writing tickets. She knows it is expensive, but it can be a temporary thing. Even a few days in one spot can be very affective. Would it be so awful if Rocky River had this kind of reputation, she thinks not. She would like to see more action from the police officers in targeting some of these repeat offenders. She appreciates all the work City Council is doing.
