MAYOR'S REPORT:

The Mayor said that there has been a lot of plowing and salting over the last few days. The city has used a lot of salt, a lot of overtime because the snow squalls just kept coming, along with blowing wind. A snow ban was implemented by the Police Department, which is typically how that occurs and that means cars cannot be parked on side streets. That will allow the plows to get through and clear the side streets efficiently, safely and effectively.

The Mayor announced that due to the snow, tree lawn leaf collection will be extended until December 29th. Snow is going to melt and if people pick up leaves in their yard, leaf collection will be around the city until December 29th. After that the city asks that residents bag leaves and yard waste which will be picked up on the tree lawn on the regular scheduled refuse collection date.

The fire station demo is scheduled for January 5th. The demo contractor is off during the holidays and

didn't want to leave the building half demoed.

The Mayor said there have been a lot of paramedic runs. One day there were 27 runs in just Rocky River. Be careful, wash your hands, wear a mask as you need to as a precaution. There are some nasty bugs going around including flu, COVID, et cetera. The paramedics average about 15 runs a day, but a high of 27 on the one day.

The Mayor announced that the CPA, the Citizen's Police Academy applications are due tomorrow. If there is anyone that is interested in going through this curriculum, the classes will begin right after the first of the year. We have a couple of people that can speak directly to what a valuable class it is.

The Mayor and the administration wish you Happy Holidays. City Hall will be closed for a half day on Christmas Eve and New Years Eve and closed all day Christmas Day and New Years Day.

President Furry is glad leaf pick up has been extended until December 29th. He has a pile of leaves underneath the snow.

President Furry stated that the operating portion of the budget is basically cost of living expenses while the capital side is a little more intensive. It was delved into more during the City Budget Meeting on December 5th. Council received a revised Exhibit A dated 12.15.25 that was in everyone's packet which will replace the prior exhibit dated 11.10.25. Mr. Furry will only discuss the changes. On Page 1, Finance went down by \$3,000, RRMC Judges went up by \$123,370 and Clerk of Court went up by \$160,630. On Page 2 Equipment Purchase went down by \$417,000, Capital Improvement went down by \$948,110, RRMC Computer A went down by \$30,000, RRMC Computer B went up by \$50,000 and RRMC Special Project went up by \$100,000, Sewer Rehab went up by \$1,237,700. All said and done taking in the pluses and minuses it increased \$438,592. As was stated, it is an aggressive budget on capital but the city has always adjusted if need be.

Mr. Sindelar said that this is further evidence of the city's continued commitment to the infrastructure projects that keep the city flowing. The city's relationship to Cleveland Water as seen on the attached, has been helpful to the city as this ordinance has an award for \$655,000 as part of this project. DiGioia was selected from five bids and were the lowest and the best bid. They were \$168,000 less than the second lowest bid and also \$500,000 lower than the engineer's estimate. That is positive and comes recommended by Strongsville and South Euclid. This project will contain sanitary and storm sewer improvements, water main improvements and pavement for the recommended streets. Mr. Sindelar stated that this is an annual item and it mirrors the employee increase. It has been the way it is and the city needs to have an engineering service on many of the projects with the engineer estimating for a good baseline for the city to see where projects should fall. The city has consistently worked with MacKay Engineering. MacKay Engineering was bought out by Wallace and Pancher. Wallace and Pancher were bought out by Mannik & Smith but are the same group of engineers. Mr. Sindelar said they have never steered the city wrong and he is comfortable moving this as it is the end of the year contract and it expires December 31st. Any projects going forward we would like to have them on board. Mr. Furry said they would maintain the same pricing until the contract is approved. Mrs. Morris thinks a 3% increase is standard from what the city experienced with all the professional dealings. She does not find it to be anything Council needs to hold off on. The Mayor noted that usually this is a two-year contract but this is only a one-year contract. The city is looking at other ways of awarding engineering services. This contract will be for the things the city does every day including waterlines, sewer projects, road payement and pedestrian amenities but the city may be looking at more specialized firms to do other work. This will be a one-year contract so the city can evaluate that. Mr. Furry said that in the first whereas everything has been on a two-year between 2015, 2017, 2019, 2021, 2023. At this time Mr. Sindelar would like to suspend the three-read rule, seconded by Mr. Furry.

Mr. Shipp read some notes from Kathryn Kerber, the Director of Planning and Community Development about this resolution. Ms. Kerber submitted this resolution to apply for a grant for the Rocky River Park Master Plan that was completed in May 2025. The overall goals for the plan are to improve park access, protect the shoreline, and address stormwater management. The next step in moving the plan forward is to complete the Schematic Design phase. This is being referred to as the Rocky River Park Lake Access Design Project, and it will include field investigation, data collection, preliminary engineering, and concept development. The Ohio Department of Natural Resources Office of Coastal Management offers Coastal Management Assistance Grant funding for projects related to coastal planning and public access. Rocky River has been awarded this grant in the past for projects at Bradstreet's Landing. Director Kerber submitted a preliminary application for the Rocky River Park Lake Access Design Project in October and was invited to submit a full application that is due on December 21st. However, this resolution can be finalized and submitted after December 21. The expected cost for this project is about \$150,000 and the grant could provide up to 50% or \$75,000. Mr. Shipp moved to suspend the three read rules, seconded by Mr. Furry.

Mr. Furry said this is a renewal of a 2024 ordinance with the Cleveland Restoration Society providing free technical to them, not to the city, assistance and optional low interest rehab loans. We had this initially when Mr. Furry started on council and dropped the program because they were not providing the service they stated but since then they have been more diligent. The cost went up slightly because we pay per house over 50 years old at \$2.19/per. Through three quarters in 2025 we had 537 homeowner contacts, 36 technical assistance without site visits and 127 site visits. There were also three loans totaling \$256,000. This could be passed with councilmanic action, but since it is a governmental entity it is on Council's agenda. Based on the dollar amount does anyone have a problem with suspending the rules? Hearing none, Mr. Furry moved to suspend the three-read rule on Ordinance No. 104-25, seconded by Mr. Sindelar.

RESOLUTION NO. 106-25 BY: MICHAEL J. O'BOYLE AN EMERGENCY RESOLUTION SUPPORTING THE PLACEMENT OF A PROPOSED SHORE STRUCTURE AND APPROVAL OF A LAKE ERIE SUBMERGED LAND LEASE FROM THE OHIO DEPARTMENT OF NATURAL RESOURCES (ODNR) ADJACENT TO PERMANENT PARCEL NO. 302-03-005 AT 22400 LAKE ROAD, ROCKY RIVER, OHIO 1st READING

Mr. Furry said that this is requesting the support of City Council for the approval of a submerged lease from ODNR from a structure along the western boundary of Bradstreet's Landing. This is needed to remove the existing structure and replace it with a natural stone structure that will extend approximately the same distance into the lake as the existing structure. The new structure will act as a boundary between Bradstreet's Landing and Harbor Village the condo complex to the west. The original intent was to restore the existing materials, but the Office of Coastal Management would not permit the repair. SmithGroup designed the new structure, and we intend to implement the project in 2027 once all permitting is completed. This is not needed for future development and can have three reads. Mr. Furry asked why Chagrin Valley Engineering do this and not Mannik & Smith. The Mayor stated that Mannik & Smith do not do lake front or submerged land lease.

Mrs. Morris asked what the design would be like. Mr. Furry said it is basically the same as what it was with natural stone. The Mayor said the city improved it and they said you cannot improve it, but it has to be the same. Harbor Village was pleased with what the city had done there.
