The Legislative Meeting was called to order by Mr. Furry, President of Council, at 7:00 p.m. in the David J. Cook Council Chambers.

MAYOR'S REPORT:

The Mayor announced that the eastbound ramp on I-90 off Hilliard will be closed this evening from 10:00 p.m. through 4:00 a.m. tomorrow morning for traffic, due to the project on I-90. To the extent that the city has information, it will be shared with the community. It was posted on the Service Department's Facebook page today.

The Mayor discussed the striping being completed on Hilliard Blvd., Lake and Detroit Roads. The lines will be painted overnight for safety concerns.

The Mayor announced that the Healthy Urban Tree Canopy Program Grant for Rocky River and Rich Snyder was awarded in the amount of \$35,000. More details will be forthcoming, but it is great to see this grant awarded to the city. There has been some meaningful tree planting and planning that has gone on.

The Mayor stated that there was a public meeting several weeks ago regarding the Spencer Creek Restoration Project. All the detailed information can be found on the city's website. There is a piece of legislation on this evening's agenda regarding this exciting project. The cost is estimated to be about \$1.4 million dollars and at this time the city has \$500,000 between a grant and State Capital funding that was received.

The Lake Road Watermain Replacement Project was funded between Avalon Drive and Parklawn Drive. There were only seven projects funded in this round and the City of Rocky River was one of the projects. This will total a little more than \$300,000 from Cleveland Water. The Mayor is happy to have that as part of the upcoming project on Lake Road.

Cleveland Water will be working on Center Ridge Road completing lead service line replacement. Cleveland Water is in the investigative stage currently. Cleveland Water along with several metropolitan areas received a

significant amount of money to abate lead lines in the water distribution system. They are advancing their efforts and will begin on Center Ridge Road from Spencer to Wooster, including W. 210th Street. Mr. Snyder said they intend to begin on Center Ridge Road by the end of September and have it wrapped up the first week of November before shopping intensifies. Cleveland Water will communicate with the retailers, school and other businesses as that project progresses.

The Mayor said that the bidding of the Wooster/Shoreland Park will take place at the end of the month.

The Police Chief submitted legislative updates for this week's agenda with one of the updates prohibiting parking three feet from a residential or commercial apron.

The Mayor announced that the budget process has started. Each department's budget is due on Friday, September 26th. Director Thomas will then work on the budget with the goal of having it to Council for the first Legislative Meeting in November.

The Mayor discussed property taxes and important legislation and initiatives to be followed at the state level. The Mayor explained that there is something called the Taxpayer Freedom Trilogy, which is three pieces of legislation. HB 420, 421 and 422 are more impactful to the schools but some could impact local municipalities. The trilogy is the elimination of continuing levies which Council has discussed; voter-initiated reductions to inside millage; and higher approval thresholds for levies up to 60% of the vote to pass a levy that is 2 mills or more. These would be very significant. All of these were vetoed by Governor DeWine in the last budget cycle. Governor DeWine has since launched a property tax reform working group, that is not a part of these three pieces of legislation. The Mayor will watch these pieces of legislation and their impacts and knows there will be a lot of discussion on these in Columbus.

The Mayor congratulated the Rocky River City Schools on their exceptional ranking, not only across the state but their ranking across the United States. A big congratulations to them as Rocky River City Schools were rated #5 in the entire state and rated 187 nationally. Huge congratulations to the students, parents, teachers, administrators, staff and the entire community that have supported the schools so well over the years.

The Mayor announced that the City of Rocky River also won an award. Cleveland Magazine has bestowed upon the city "The Best New Pier" award which will be highlighted in the "Best of Cleveland". The Mayor said that in all honesty, the city has the only new pier but our pier is the best of the only new pier. The Mayor really appreciates this award and it is great to have Bradstreet's Landing receive one more accolade.

The League of Women Voters will host a series of candidate forums at Memorial Hall beginning this Wednesday, September 10th. The Forum will be for the candidates running for Judge and Clerk of Court.

This Thursday, 9/11, the city will be having the traditional remembrance for 9/11 and Council President will be speaking. All the community is invited to attend. A ReadyNotify was sent out today regarding the remembrance.

This Saturday, September 13th is Constitution Day and Councilman Sindelar will be reading a Proclamation that the administration drafted on behalf of City Council and the administration. There will be a walk from St. Thomas Lutheran Church to City Hall Campus that kicks off at 10:00 a.m. The ceremony will commence at approximately 10:15 a.m. If it is raining, the group will come into Council Chambers in City Hall.

NEW BUSINESS:

Mr. Hunt said that due to the absence of Councilwoman Morris, he will have his sponsored legislation read but will defer general substantive discussion until the Committee-of-the-Whole Meeting next week.

ORDINANCE NO. 49-25**BY: THOMAS J. HUNT****AN EMERGENCY ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER, SECTION 351.03 (a) (2), ENTITLED “PROHIBITED STANDING OR PARKING PLACES”, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT “A”****1st READING**

Mr. Hunt said the Mayor touched on this in her report. The city has had numerous complaints regarding parking this summer and earlier in the year. The three-foot distance came as a recommendation from Chief Lichman. The Chief also included a summary of forty different cities and three feet was the mean distance and the most reasonable distance for parking away from aprons. Mr. Hunt feels this will help alleviate some of the parking issues that the city is having.

- Mr. Furry stated that Council is overusing the emergency ordinance provision and is asking the administration to be more thoughtful of this in future legislation. The Mayor said that the Chief wanted the legislation to go into effect immediately and that is why the emergency language is incorporated.

ORDINANCE NO. 50-25**BY: THOMAS J. HUNT****AN EMERGENCY ORDINANCE AMENDING AND ENACTING NEW SECTION 521.14 OF THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER TO PROHIBIT CAMPING ON PUBLIC PROPERTY AND WITHIN RIGHTS OF-WAY, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT “A”****1st READING**

Mr. Hunt said that this has been prompted by residents and business complaints about individuals over the course of the spring and summer sleeping in makeshift shelters at Elmwood and Rocky River Parks. Mr. Hunt asked Council to please review the exhibit attached as this will be discussed in depth next week.

- Mr. Furry asked for an example of an affirmative defense. Mr. O’Shea said that from a practical functional standpoint, the city has had a recent uptake in the number of homeless people living in and around certain areas of Rocky River. The homeless hang out in parking lots and they sometimes want to be arrested. The city has tried to figure out the best way to accommodate what is essentially their right to move around in the

city. If they are warned by the property owner that they are not permitted to come back, they become a trespasser if they return. The Law Director and the Chief thought it might be more palpable to have this type of ordinance rather than charge these people with trespassing. It is imperfect, but there are some people that abuse it on purpose and that is why they would like the ordinance to pass.

- Mr. Sindelar asked if there were options to move the homeless into a shelter. Mr. O'Shea said that it is done as a practical matter every now and then, but it is not the city's responsibility to take them to a shelter. The Mayor asked the Chief and NEOCH, which is the Northeast Ohio Coalition for the Homeless to do some training with the officers. The city wants those experiencing homelessness to understand all the resources available to them. Mr. O'Shea said that mental health systems do not exist and that mental health services are the most underfunded aspect of county and state government.

ORDINANCE NO. 51-25

1st READING

Mr. Hunt stated that this is a companion piece to the previous ordinance that prohibits sleeping in municipal parks. Parks are open from 6:00 a.m. until sunset and after such time the parks are cleared. In the CAD reports it shows that a lot of people are straggling as late as 10–10:30. This will be discussed further at the next meeting.

ORDINANCE NO. 52-25

1st READING

Mr. Hunt hopes this ordinance was not unexpected by Council. Council has talked about golf carts and differences and distinctions between low-speed vehicles and under speed vehicles. Ordinance No. 52-25 had a revised version at Council's desk this evening which will be the ordinance that will go forward. The ordinances were separated out but there were some redundancies and the Chief recommended that it all be put on one. Ordinance No. 53-25 will be read after this and then it will be removed from the agenda. These are prohibitions for under speed and low speed vehicles. Please review the exhibit that is attached.

- Mr. Furry has wanted this legislation on the books for a while. He has seen someone that drives over from Lakewood to the Market and even at the D.A.R.E. Meeting in June, someone had their golf cart parked in the hockey rink parking lot. It is an accident waiting to happen.

ORDINANCE NO. 54-25**BY: THOMAS J. HUNT****AN EMERGENCY ORDINANCE AMENDING CHAPTER 729.01 DEFINITIONS AND ADDING SECTION 729.021 OF THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER TO PROHIBIT CERTAIN SOLICITATION PRACTICES IN ORDER TO PROMOTE PUBLIC SAFETY, COMMERCIAL SECURITY, AND TRAFFIC SAFETY, AS FURTHER DESCRIBED IN EXHIBITS “A” AND “B”****1st READING**

Mr. Hunt stated that this goes hand in hand with what Law Director O’Shea was discussing in terms of folks that the city has had complaints about for some time now with very aggressive types of solicitation. This is an ordinance that would promote safety and hopefully set some hard and fast rules regarding prohibited locations and manner of solicitation including residential areas. There are stickers that are available for non-solicitation that homeowners can use. Please review the proposed exhibit and the language. This will be discussed at the next meeting.

- Mr. Furry said he knows that you can get a solicitor’s permit but some do not. Do they receive this legislation so they know what they can and cannot do. The Mayor said there is a whole sheet they receive when applying for a permit. Mr. Snyder said that these permits go through his office and they know what the rules are. They are not supposed to approach a home that has a sticker and there are certain hours of operation along with a paid fee.
- The Mayor said that the other piece to this is educating the residents so they ask solicitors to see their permit. Each solicitor should have a copy of the permit if soliciting. Mr. Hunt said that is a great point as there are several reports where residents are being diligent and call to verify to avoid any conflicts or confrontations wherever possible.

ORDINANCE NO. 55-25**BY: JEANNE GALLAGHER****AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY SERVICE TO PURCHASE ONE (1) ELGIN PELICAN STREET SWEEPER FOR THE SERVICE DEPARTMENT UNDER A SOURCEWELL COOPERATIVE PURCHASING CONTRACT FROM A & H EQUIPMENT AT A COST NOT TO EXCEED \$312,011.20, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT “A”****1st READING**

Mrs. Gallagher stated that A & H is in Independence, which is perfect for the needs as far as purchasing a large piece of equipment. The current sweeper is a 2004 and has increased maintenance costs and has reached the end of its service life due to aging parts and repairs. The Pelican is the best sweeper on the market and is what the city has used for over twenty years. Ken Shuster, the Street Department Supervisor is asking Council to approve this purchase. The Streets Department and mechanics performed an evaluation between the Pelican, the Ravo5 iSeries and the Bucher CityCat 5006 and determined that the Elgin Pelican performs better than the others. It is dependable and easy to work with. Frank Sinitio, the head mechanic, likes the Pelican better than the other two. This is a necessary piece of equipment for storm water management and MS4 compliance. It helps prevent flooding and pollution by keeping debris out of the catch basins and the Lake Erie watershed. The current Pelican performs through fall leaves, spring sediment, storm debris and winter salt. The city has a great relationship with A & H Equipment in Independence and they are close in proximity and will have parts available. This will be discussed more at next week’s meeting. This will have three full reads.

- Mr. Furry said the old one was sold on gov.deals and asked what it sold for. Mr. Snyder said the 1992 streetsweeper was sold for about \$1,300. It was completely inoperable. It had not moved in a while. The 2004 will be a backup allowing the Service Department to have two sweepers going at one time.

ORDINANCE NO. 56-25**BY: BRIAN J. SINDELAR**

AN EMERGENCY ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT FOR THE REMOVAL OF THE EXISTING UNDERGROUND FUEL TANKS AT THE SERVICE GARAGE WITH COLLINS EQUIPMENT CORPORATION, UNDER THE STATE COOPERATIVE PURCHASING ACT, AT A COST NOT TO EXCEED \$56,318.67, AS FURTHER DESCRIBED IN EXHIBIT "A"

1st READING

Mr. Sindelar said that Collins Equipment has done the previous work on similar tanks at City Hall. This is basically the same project. The city has worked with them before and trusts them as they did a good job before. This is an example of the State Coop coming in handy and getting a better price than on the Open Market potentially. The administration has requested a Special Meeting next week so this can be approved sooner. Mr. Snyder said this is for the removal of the underground tanks that are still in use. The above tanks are in and are ready to go. They will be operational and the city is required to remove the underground tanks quickly by the State Fire Marshall's office.

- Mr. Furry asked if there is any reason to believe that there will be any soil contamination or need any remediation. Mr. Snyder said that the city does not know, but this was billed into this legislation in case. When the tanks are removed, the water below will be tested.

RESOLUTION NO. 57-25**BY: PAUL SHIPP**

AN EMERGENCY RESOLUTION AUTHORIZING THE MAYOR TO RECEIVE FUNDS IN THE AMOUNT OF \$200,000.00 AND ADMINISTER AN AGREEMENT WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES FOR THE CENTER RIDGE GATEWAY IMPROVEMENT PROJECT, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

1st READING

Mr. Shipp stated that this is a resolution requesting authorization to administer \$200,000 in grant money that was awarded in the 2023/2024 Fiscal Year for State Capital Funding to be used for the Pedestrian and Greenscape Improvements as part of the Center Ridge Gateway Project. The appropriations for the funds are part of Ohio House Bill 2 through the Parks and Recreation Fund in the Ohio Department of Natural Resources, who will be administering the grant. \$4,000 of the funds will be used by ODNR for administration costs with the city receiving \$196,000. Mr. Snyder has a goal to bid the Center Ridge Gateway Project in early October.

- Mr. Snyder humbly requested that this resolution be passed after the first reading with a rule's suspension this evening. The agreement needs to be in place to receive the \$200,000.
- Mr. Furry asked how this is through ODNR and the Parks and Recreation Improvement Fund. Mr. Snyder said that when they put in for the State Capital funds, he does not know what path or agency they choose. The funds for this must be allocated towards pedestrian improvements and greenscape. The boulevards on Center Ridge Road and the pedestrian improvements will be what this funding is used for.

Mr. Hunt said that Council is hesitant to pass legislation on the first read, but certainly as this is receiving grant funds, he does not have an issue with it. The Mayor added that normally Council would not see this acceptance. This is State Capital money and is awarded to the city but then the city must accept the receipt of that money. Mr. Sindelar stated that Council does not suspend the three read rules often.

Mr. Shipp moved for a rules suspension to pass this legislation on one read, seconded by Mr. Hunt.

ORDINANCE NO. 58-25

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR THE CURRENT EXPENSES OF THE CITY OF ROCKY RIVER, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2025 AND TO AMEND AMENDED ORDINANCE NO. 88-24

1st READING

Mr. Furry stated that the administration does mid-year budget reviews in July and this supplemental is the result of that and has both pluses and minuses. The first is salary in the Mayor’s Office. The previous Executive Assistant, Mary Ellen Umerley basically had a time share of both time and expense with the Law Department. With the hiring of Michelle Root, that original appropriation changed. In Finance the staffing plan changed from the addition of the Finance Manager precipitating the increase. Fringe benefits relate to the Health Insurance costs and enrollment changes that have occurred for the Mayor’s Office and Finance Department. The amounts are related to pension costs of the various salary adjustments. The other is that Chief Lenart would like to be prepared for potential equipment and vehicle repair costs for the remainder of 2025. Lastly, there are several meaningful adjustments to certain funds of the Municipal Courts which have been discussed with the Court Officials. There is a new fund for the court, “Indigent Driver Alcohol Surplus” fund as authorized by the Ohio Revised Code 4511.191(H). Because of the provisions of that Ohio Revised Code Chapter, there is an interplay between the Court’s Indigent Driver Alcohol and the Indigent Driver Alcohol Surplus funds and both need supplemental appropriations. President Furry stated that we are stewards of the court.

ORDINANCE NO. 59-25

AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A SUPPLEMENTAL AGREEMENT WITH PERSPECTUS ARCHITECTURE, FOR THE ARCHITECTURAL DESIGN AND ENGINEERING SERVICES FOR THE FIRE STATION IN AN AMOUNT NOT TO EXCEED \$317,500.00, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT “A”

1st READING

Mr. Hunt said that since the original contract was authorized in 2024, Perspectus is requesting a supplemental agreement because the scope of the design has grown from 20,000 square feet to 25,000 square feet, which will drive up the actual cost for the building. This was originally a \$10 million project but is now a \$13 million project and based upon the formula that Perspectus uses, their fee for the design and scope has increased from \$836,000 to \$1,153,500.00 with the additional supplemental amount of \$317,500.00. Perspectus has been very accommodating and responsive to the request of the administration, Fire Department and Boards and Commissions. This contract needs to be supplemented to ensure the building progresses and is completed as needed. This will be a Fire Station that can service the needs of the community for another 50 years just as the original building has. Council wants to be sure it is done right with the appropriate scale and necessary square footage being available to the Fire Department for its apparatus and personnel.

- Mr. Furry asked what the current square footage is. Mr. Snyder said it is 9,000 square feet. The firefighters are packed in there. Mr. Snyder stated that there are also additional responsibilities for the firefighters. The WestShore water rescue equipment needs to be housed here occasionally. There will be two fire poles in the new station.
- Mr. Sindelar asked if this will be designed seamlessly to match the new police station. The Mayor said yes, it will be complimentary.

ORDINANCE NO. 60-25**BY: PAUL SHIPP****AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A SUPPLEMENTAL AGREEMENT WITH SMITHGROUP, FOR THE BRADSTREET'S LANDING SPENCER CREEK STREAM RESTORATION PROJECT IN AN AMOUNT NOT TO EXCEED \$142,850.00, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"****1st READING**

Mr. Shipp asked Director Snyder to give an overview of which phase of this project this ordinance will cover. Mr. Snyder said that this legislation covers tasks 3 & 4 of the agreement with SmithGroup which are the architects and engineers that have been working on Bradstreet's Landing. The original proposal was for design, hydraulic modeling and technical resources that went into figuring out what needed to be done with Spencer Creek before coming up with a plan. Task 1 was performed with a purchase order to do the field work and get information. Task 2 was for the technical resources and starting the design process which brings us up to where we are now. With that information, the path was determined for the build and what approach to take for the restoration of this.

This legislation is for Tasks 3 & 4, which is the overall design of the improvement project on Spencer Creek and includes improvements for the green space that is currently there in the upland area of the park. Director Snyder added that there is some erosion on the east end of the pedestrian bridge that this will address with their engineering resources also. This gets the city through complete engineering, bid process and bidding support. There was also a public meeting regarding this project in August.

PUBLIC COMMENT: Mr. Mark Rantala, 2709 Country Club Blvd., thanked Council and the city for having such great recreation facilities. He loves the outdoor and indoor pools. He understands the challenges that lifeguards have been and he knows why the outdoor pool closes when school opens. Some of the best weather of the year though is in late August and early September. As you plan the budget for next year, he would like Council to consider the possibility of the two weeks after school opens until Labor Day to continue the adult swim from 7:00-9:00 a.m. It was full every day and then it just quit. Perhaps also consider two bonus weekends after Labor Day when it is open to the whole public with both adults and kids. He is hoping the city finds a way to hire more lifeguards, maybe from other pools or have a bonus for those two weeks or whatever. He thinks it is a shame to have such a wonderful asset and not use it when the weather is still good. The dog swim can be pushed back two weeks. Mr. Furry said that lifeguards are always a challenge. The wage ordinance was increased a couple of years ago to entice more lifeguards and lately adjusting it to add free lifeguard training, but they must commit to being a lifeguard. It is a challenge.
