SWEARING IN OF POLICE OFFICERS:

Chief Lichman thanked everyone for coming. Today marks an important day in the careers of both Matthew Blazer and Bradley DiMatteo. Lakewood's sewer rates are higher than Rocky River so the city subsidizes these homeowners' rates, so everyone in Rocky River pays the same mcf.
