AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT
WITH THE OHIO PATROLMEN'S BENEVOLENT ASSOCIATION,
SERGEANTS, LIEUTENANTS AND CAPTAIN BARGAINING UNIT,
OF THE ROCKY RIVER POLICE DIVISION,
AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS, the City Administration and the Ohio Patrolmen's Benevolent Association representing the Sergeants, Lieutenants and Captain Bargaining Unit of the Rocky River Police Division have reached accord for an agreement effective January 1, 2016 through December 31, 2018; and

WHEREAS, said agreement is for the establishment of proper standards of wages, hours and other conditions of employment and to assure the rights of both the employees and the City of Rocky River, representing its citizens; and

WHEREAS, it is the opinion of the Administration and Council of the City of Rocky River that said agreement be entered into.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

Section 1. That the Mayor be and she is hereby authorized to enter into an agreement with the Ohio Patrolmen's Benevolent Association representing the sergeants, lieutenants and captain of the Rocky River Police Division, as further described in the attached Exhibit "A".

Section 2. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that this agreement is necessary to maintain and provide proper services to the citizens, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

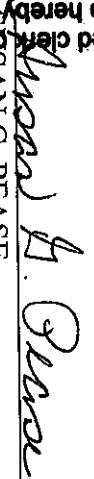

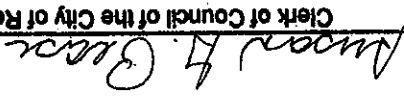
