AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO EXERCISE THE OPTION TO RENEW FOR ONE (1) YEAR THE PURCHASE OF JANITORIAL SUPPLIES FOR THE CITY OF ROCKY RIVER FROM OHIO VALLEY SUPPLY AND MAINTENANCE CO. AT A COST NOT TO EXCEED \$55,000.00 AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: in 2015, the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of janitorial supplies for a one (1) year period with an option to renew for an additional one year for the City of Rocky River; and

WHEREAS: five (5) bids were received and after review by the Director of Public Safety-Service, she deems it to be in the best interest of the City of Rocky River to accept the lowest and best bid for janitorial supplies from Ohio Valley Supply and Maintenance Co., at a cost not to exceed \$55,000.00, copies of bids are on file in the office of the Director of Public Safety-Service.

WHEREAS: pursuant to ordinance 43-15 City Council had determined that it was in the best interest of the City of Rocky River to accept the lowest and best bid for janitorial supplies from Ohio Valley Supply and Maintenance Co. for 2015, with an option to renew for an additional one year at the same cost. City Council now determines that it is in the best interest of the City to renew the terms and conditions of this bid for one (1) year.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River be authorized to purchase janitorial supplies from Ohio Valley Supply and Maintenance Co., 2011 St. Clair Ave N.E., Cleveland, Ohio 44114-4047, and this contract includes an option for renewal on an annual basis in an amount not to exceed Fifty Five Thousand Dollars and 00/100 (\$55,000.00).

SECTION 2. That janitorial supplies shall be charged to the following funds: General, Recreation Center, Waste Water Treatment Plant Utility, Senior Center, Marine Patrol, Refuse & Recycling, Sanitary Sewer and Street Construction Maintenance & Repair, which funds are already appropriated.

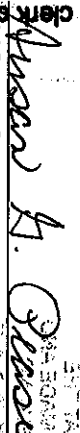
