AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE A 2017 FORD F-550 DUMP TRUCK FOR THE SERVICE DIVISION FROM MONTROSE FORD AT A TOTAL COST NOT TO EXCEED \$51,995.00

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) 2017 one-ton dump truck for the City of Rocky River Service Division; and

WHEREAS: two (2) bids were received for a one-ton dump truck, copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to select the lowest and best bid for a one-ton dump truck vehicle, for the Service Division from Montrose Ford, 3960 Medina Rd., Akron, OH 44333.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River is hereby authorized to purchase a 2017 Ford F-550 dump truck with snow plow package at a total cost not to exceed Fifty-One Thousand Nine Hundred Ninety-Five Dollars and 00/100 (\$51,995.00) from Montrose Ford.

SECTION 2. That \$51,995.00 for a one-ton dump truck with snow plow package shall be paid for from the 1-Ton Truck account - Equipment Purchase Fund.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to update the Service Division vehicle fleet before snow plowing season and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
