AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE SERVICES FOR THE REMOVAL OF GRIT AND SCREENINGS FOR THE WASTEWATER TREATMENT PLANT FROM RUMPKE OF NORTHERN OHIO, INC. AT \$65.00 PER TON FOR 2017

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the removal of grit and screenings for the Wastewater Treatment Plant;

WHEREAS: two (2) bids were received on September 30, 2016, and were reviewed by the Wastewater Treatment Plant Superintendent, a copy of said bids are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service and Wastewater Treatment Plant Superintendent have determined that it is in the best interest of the City and the Wastewater Treatment Plant to accept the lowest and best bid for the removal of grit and screenings from Rumpke of Northern Ohio, Inc. at \$65.00 per ton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of grit and screenings for one (1) year with an option to renew on an annual basis from Rumpke of Northern Ohio, Inc., 10795 Hughes Road, Cincinnati, Ohio 45251 at \$65.00 per ton.

SECTION 2. That funds for the removal of grit and screenings shall be paid from the Wastewater Treatment Plant Utility Fund.
