AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE
DIRECTOR OF PUBLIC SAFETY-SERVICE TO AGREE TO RENEW A
CONTRACT FOR VARIOUS INSURANCE COVERAGES FOR THE CITY OF
ROCKY RIVER WITH MCGOWAN INSURANCE COMPANY FOR THE YEAR 2017
AT A TOTAL COST OF \$178,157.00

WHEREAS: pursuant to ordinance 85-14, City Council determined that it was in the best interest of the City to accept the insurance proposal for various insurance coverages from McGowan Insurance Company with options for annual renewal; in Ordinance 80-15, City Council exercised its option to renew the same insurance coverage for 2016; and

WHEREAS: the Mayor and Director of Public Safety-Service have determined it to be in the best interest of the City of Rocky River to exercise its option to renew for an additional year of 2017 the contract for insurance coverages for the City from McGowan Insurance Company, 20595 Lorain Rd., Fairview Park, OH 44126.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

Section 1. That the Mayor and Director of Public Safety-Service of the City of Rocky River are hereby authorized to enter into a renewal of insurance coverage which includes an option to renew annually with a rate guarantee offering the City an opportunity to renew in line with current value of exposures for the purchase of Buildings and Contents, Extra Expense, Valuable Papers, Equipment Floater, General Liability, Automobile Liability, Umbrella Liability, Crime, Public Officials Liability, Ambulance Attendants' Errors and Omissions, Police Professional, Boat, Boilers and Machinery, EDP Dollar Value Insurance, Fine Arts Floater and Exhibit Floater for the City of Rocky River for 2017 at a cost of One Hundred Seventy Eight Thousand One Hundred Fifty Seven Dollars and 00/100 (\$178,157.00) through McGowan Insurance Company, insurance agents as underwritten by the Argonaut Insurance Company and the American Alternative Insurance Company.

Section 2. That the net cost of the purchase of this insurance shall be appropriated and paid from the various accounts of various funds of the City.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and for the further reason to keep current the contract for this service and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
