AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO AGREE TO RENEW A CONTRACT FOR VARIOUS INSURANCE COVERAGES FOR THE ROCKY RIVER WASTE WATER TREATMENT PLANT WITH MCGOWAN INSURANCE COMPANY FOR THE YEAR 2017 AT A TOTAL COST OF \$66,609.00

WHEREAS: pursuant to ordinance 84-14, City Council determined that it was in the best interest of the City to accept the insurance proposal for insurance coverages from McGowan Insurance Company with options for annual renewal; in Ordinance 79-15, City Council exercised its option to renew the same insurance coverage for 2016; and

WHEREAS: the Mayor and Director of Public Safety-Service have determined it to be in the best interest of the City to exercise its option to renew for the additional year of 2017 the contract for insurance coverages for the Rocky River Waste Water Treatment Plant from McGowan Insurance Company, 20595 Lorain Rd., Fairview Park, Ohio 44126.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor and Director of Public Safety-Service of the City of Rocky River are hereby authorized to enter into a renewal of insurance coverage which includes an option to renew annually with a rate guarantee offering the Waste Water Treatment Plant an opportunity to renew in line with current value of exposures for the purchase of Buildings and Contents, Extra Expense, Valuable Papers, Equipment Floater, General Liability, Boilers and Machinery Insurance and Umbrella Liability, Public Officials Liability, Property in Open Insurance and Automobile Liability for the Rocky River Waste Water Treatment Plant for 2017 at a cost of Sixty Six Thousand Six Hundred Nine Dollars and 00/100 (\$66,609.00) through McGowan Insurance Company, insurance agents and as underwritten by the Argonaut Insurance Company.

SECTION 2. That the net cost of the purchase of this insurance shall be appropriated and paid from the Wastewater Treatment Plant Utility Fund.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and for the further reason to keep current the contract for this service and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
