AN EMERGENCY RESOLUTION AUTHORIZING THE MAYOR OR HER DESIGNEE TO MAKE APPLICATION TO THE CUYAHOGA COUNTY COMMUNITY DEVELOPMENT SUPPLEMENTAL GRANT (CDSG) PROGRAM FOR THE WOOSTER ROAD SIGN, SIGNAL AND PEDESTRIAN SAFETY PROJECT

WHEREAS, Cuyahoga County has determined that the land located on the west side of Wooster Road, between the following addresses: 1640 Wooster Road and 2154 Wooster Road, is eligible for consideration for a grant from the Cuyahoga County Community Development Supplemental Grant Program; and

That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that timely response is necessary to participate in the grant process, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor: otherwise it shall take effect and be in force from and after the earliest period allowed by law.
