ORDINANCE NO. 9-16

AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE ONE (1) 2015 CATERPILLAR WHEEL LOADER FOR THE SERVICE DIVISION FROM OHIO CAT AT A COST NOT TO EXCEED \$123,417.00

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) wheel loader for the City of Rocky River Service Division; and

WHEREAS: seven (7) bids were received for the wheel loader, copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the bid from Ohio CAT was responsive to the specifications and offered the City a superior product that will be supported by easily obtainable parts and knowledgeable technicians to ensure the ongoing viability of this machinery.

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to accept the best bid for a wheel loader for the Service Division from Ohio CAT, 3993 East Royalton Road, Broadview Heights, OH 44147 at cost not to exceed One Hundred Twenty Three Thousand Four Hundred Seventeen Dollars and 00/100 (\$123,417.00).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River be and is hereby authorized to purchase one (1) wheel loader at a cost of \$134,917.00 less trade cost for a 2001 New Holland front loader for \$11,500.00 for a total cost not to exceed One Hundred Twenty Three Thousand Four Hundred Seventeen Dollars and 00/100 (\$123,417.00).

SECTION 2. That \$123,417.00 shall be paid from the Equipment Purchase Fund – Vehicle Purchase account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to replace equipment that is out of service (replacing a 2001 front loader) and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
