AN ORDINANCE AMENDING SECTION 957.01 ENTITLED "USE FEES AND SECURITY DEPOSIT" OF THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER, AND AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: it is the desire of the Administration, the City Council of the City of Rocky River, and its Recreation Department, that Section 957.01 entitled "Use Fees and Security Deposit" of the Codified Ordinances of The City of Rocky River be amended regarding the use fees for the Elmwood Cabin, as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That Section 957.01 entitled "Use Fees and Security Deposit" of the Codified Ordinances of the City of Rocky River be amended as further described in the attached Exhibit "A".

SECTION 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.

957.01 USE FEES AND SECURITY DEPOSIT.

“Resident” as used in this Section means a group of which fifty percent (50%) or more of all members are residents of the City of Rocky River. “Non Resident” means a group other than a local group. The following fees shall be charged for use of the Elmwood Park Cabin:

A.	Monday thru Friday until 5:30 p.m. excluding holidays	\$60.00 75.00	\$100.00115.00	\$100.00125.00
B.	Monday thru Friday after 5:30 p.m. including weekends and holidays	\$100.00150.00	\$160.00225.00	\$100.00125.00
C.	Overnight use- must be out by 10:00 a.m.	\$115.00175.00	\$180.00250.00	\$100.00125.00
D.	In recognition of reciprocal use of school facilities, fee will be waived for Rocky River Board of Education school-sponsored activities (i.e. clubs, athletic teams), subject to approval by Director of Recreation.			
E.	Failure to abide by the rules established for the use of Elmwood Cabin may result in loss of a portion of all of the security deposit and may also result in loss of future rental privileges, both as determined by the Director of Recreation.
