AMENDED ORDINANCE NO. 3-17

AN ORDINANCE AUTHORIZING THE ADJUSTMENT OF
SEWER RATES PAID TO THE CITY OF LAKEWOOD FOR
WASTEWATER TREATMENT SERVICES
FOR THE VALLEYVIEW SEWER DISTRICT

WHEREAS, the City of Rocky River has an agreement with the City of Lakewood for the treatment of sanitary sewage being discharged from an area in the City of Rocky River comprising approximately fifteen (15) acres hereinafter called the "Valleyview Sewer District"; and

WHEREAS, Lakewood City Council adopted Ordinance No. 46-16 on December 19, 2016 adjusting sewer rates charged in the City of Lakewood from \$5.58 per hundred cubic feet (ccf) of metered water consumption (or \$55.80 per thousand cubic feet, mcf) to \$6.20 per ccf (or \$62.00 per mcf); and

WHEREAS, it is determined by this Council that it would be beneficial for the City of Rocky River to continue said agreement and accept said rate increase to \$62.00 per mcf, effective January 1, 2017 plus a millage equivalent rate of \$8.72 per mcf for a total rate of \$70.72 per mcf.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

Section 1. The City of Rocky River hereby accepts the rate increase adopted by the City of Lakewood to the sum of \$62.00 per mcf for the treatment of wastewater being discharged from approximately one hundred nine (109) single family residences in the area of said "Valleyview Sewer District".

Section 2. The City of Rocky River hereby accepts the millage equivalent rate of \$8.72 for 2017 millage equivalent rate as may be calculated thereafter for the treatment of wastewater being discharged from approximately one hundred nine (109) single family residences in the area of said "Valleyview Sewer District".

Section 3. That the charges incurred pursuant to said Agreement shall be due and payable from the Sanitary Sewer Fund (Fund No. 266).

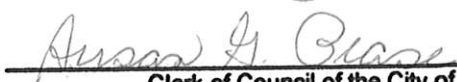
