AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE ONE (1) 2018 SEWER JET / VACUUM TRUCK FOR THE SERVICE DIVISION FROM BEST EQUIPMENT CO., INC. AT A COST NOT TO EXCEED \$298,760.00

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) sewer jet / vacuum truck for the City of Rocky River Service Division; and

WHEREAS: three (3) bids were received for the sewer jet / vacuum truck, copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to select the best and lowest bid for a sewer jet / vacuum truck, which had been a demonstration vehicle, for the Service Division from Best Equipment Company Inc., at a total cost not to exceed Two Hundred Ninety-Eight Thousand Seven-Hundred Sixty Dollars and 00/100 (\$298,760.00).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River be and is hereby authorized to purchase one (1) sewer jet / vacuum truck from Best Equipment Company Inc., 12359 Abbey Road, North Royalton, Ohio 44133 at a cost of \$358,760.00 less trade cost for a 2000 Freightliner Vactor Utility Truck for \$60,000.00 for a total cost not to exceed Two Hundred Ninety-Eight Thousand Seven Hundred Sixty Dollars and 00/100 (\$298,760.00).

SECTION 2. That \$298,760.00 shall be paid from the Equipment Purchase Fund – Vehicle Purchase account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to replace equipment that is out of service (replacing a 2000 sewer jet / vacuum truck) and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
