AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO RENEW AN AGREEMENT TO PURCHASE SODIUM BISULFITE FOR THE WASTEWATER TREATMENT PLANT FROM JCI JONES CHEMICALS, INC. AT \$1.145 PER GALLON FOR THE YEAR 2018 AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: in 2015 the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that allow annual renewals for the purchase of sodium bisulfite for the Wastewater Treatment Plant; and

WHEREAS: two (2) bids were received and after review by the Wastewater Treatment Superintendent, it was determined to accept the lowest and best bid for the sodium bisulfite from JCI Jones Chemicals, Inc., copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: pursuant to Ordinance 72-15 City Council has determined that it is in the best interest of the City of Rocky River to accept the lowest and best bid for a period of one year, sodium bisulfite from JCI Jones Chemicals, Inc., at \$1.145 per gallon. In Ordinance 60-16 City Council authorized renewal of the agreement for one additional year at the same cost.

WHEREAS: City Council has determined that it is in the best interest of the City of Rocky River to authorize renewal of the agreement for one (1) additional year from JCI Jones Chemicals, Inc. at \$1.145 per gallon.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase sodium bisulfite for 2018 with renewal available on an annual basis from JCI Jones Chemicals, Inc., 2500 Vanderhoof Road, Barberton, Ohio 44203 at \$1.145 per gallon.

SECTION 2. That funds for the purchase of sodium bisulfite shall be paid from the Wastewater Treatment Plant Utility Fund.
