AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE FERRIC CHLORIDE FOR THE WASTEWATER TREATMENT PLANT FROM PVS TECHNOLOGIES, INC., AT \$468.00 PER DRY TON FOR 2018

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that allow annual renewals for the purchase of ferric chloride for the Wastewater Treatment Plant; and

WHEREAS: on October 6, 2017, two (2) bids for ferric chloride were received, and reviewed by the Wastewater Treatment Plant Superintendent, copy of said bids are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service and Wastewater Treatment Plant Superintendent have determined it to be in the best interest of the City and the Wastewater Treatment Plant to accept the lowest and best bid which allows annual renewals from PVS Technologies, Inc., 10900 Harper Avenue, Detroit, MI 48213 at \$468.00 per dry ton; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase ferric chloride for 2018 from PVS Technologies, Inc., 10900 Harper Avenue, Detroit, MI 48213 at \$468.00 per dry ton.

SECTION 2. That funds for the purchase of ferric chloride shall be paid from the Wastewater Treatment Plant Utility Fund.
