AN ORDINANCE AMENDING THE CODIFIED ORDINANCES
OF THE CITY OF ROCKY RIVER, SECTION 351.03, ENTITLED "PROHIBITED
STANDING OR PARKING PLACES", AS FURTHER DESCRIBED IN THE ATTACHED
EXHIBIT "A"

WHEREAS: the Administration of the City of Rocky River, has deemed it necessary to
amend Section 351.03 of our Codified Ordinances regarding prohibited standing or parking
places on the fire hydrant side of residential streets; and

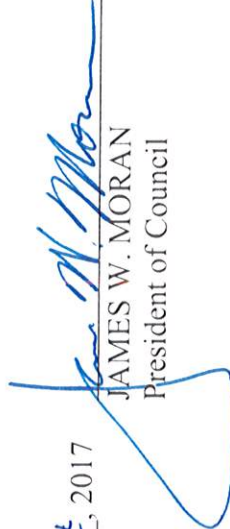
WHEREAS: it is the desire of the Administration and Council of the City of Rocky River
that Section 351.03 of the Codified Ordinances of the City of Rocky River be amended
concerning prohibited standing or parking places on the fire hydrant side of residential
streets, as further described in the attached Exhibit "A"; and

WHEREAS: a list of the streets within the City of Rocky River which may be affected by
the amendment to Section 351.03 is attached as Exhibit "B".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY
RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That Section 351.03 entitled "Prohibited Standing or Parking Places" of the
Codified Ordinances of the City of Rocky River be amended as further described in the
attached Exhibit "A".

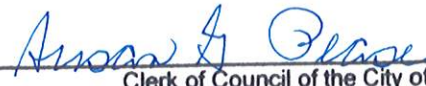

351.03 PROHIBITED STANDING OR PARKING PLACES.

(a) No person shall stand or park a vehicle, except when necessary to avoid conflict with other traffic or to comply with the provisions of this Traffic Code, or while obeying the directions of a police officer or a traffic control device, in any of the following places:

- (1) On a sidewalk, curb or street lawn area, except a bicycle;
- (2) In front of a public or private driveway;
- (3) Within an intersection;
- (4) Within ten feet of a fire hydrant;
- (5) On a crosswalk;
- (6) Within twenty feet of a crosswalk at an intersection;
- (7) Within thirty feet of, and upon the approach to, any flashing beacon, stop sign or traffic control device;
- (8) Between a safety zone and the adjacent curb or within thirty feet of points on the curb immediately opposite the end of a safety zone, unless a different length is indicated by a traffic control device;
- (9) Within fifty feet of the nearest rail of a railroad crossing;
- (10) Within twenty feet of a driveway entrance to any fire station and, on the side of the street opposite the entrance to any fire station, within seventy- five feet of the entrance when it is properly posted with signs;
- (11) Alongside or opposite any street excavation or obstruction when such standing or parking would obstruct traffic;
- (12) Alongside any vehicle stopped or parked at the edge or curb of a street;
- (13) Upon any bridge or other elevated structure upon a street, or within a street tunnel;
- (14) At any place where signs prohibit stopping, standing or parking, or where the curbing or street is painted yellow, or at any place in excess of the maximum time limited by signs;
- (15) Within one foot of another parked vehicle;
- (16) On the roadway portion of a freeway, expressway or thruway.
- (17) On the fire hydrant side of any public street within residentially zoned districts, unless the residential street exceeds thirty (30) feet in width, or unless the street contains parking areas by design or is otherwise permitted by signage.
- (b) Except as otherwise provided in this subsection, whoever violates this section is guilty of a minor misdemeanor. If, within one year of the offense, the offender previously has been convicted of or pleaded guilty to one predicate motor vehicle or traffic offense, whoever violates this section is guilty of a misdemeanor of the fourth degree. If, within one year of the offense, the offender previously has been convicted of two or more predicate motor vehicle or traffic offenses, whoever violates this section is guilty of a misdemeanor of the third degree.
