AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE ONE (1) COMPACTOR REFUSE EJECTOR 75 CUBIC YARD TRANSFER TRAILER FOR THE SERVICE DIVISION FROM REFUSE EQUIPMENT & TRUCK SERVICES, INC. AT A COST NOT TO EXCEED \$68,075.00

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) Compactor Refuse Ejector Trailer for the City of Rocky River Service Division; and

WHEREAS: one (1) bid was received for the compactor refuse ejector trailer, copy of which is on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to select the best bid for a compactor refuse ejector 75 cubic yard transfer trailer from Refuse Equipment & Truck Services, Inc., at a total cost not to exceed Sixty-Eight Thousand Seventy-Five Dollars and 00/100 (\$68,075.00).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River be and is hereby authorized to purchase one (1) Compactor Refuse Ejector 75 Cubic Yard Transfer Trailer from Refuse Equipment & Truck Services, Inc., 237 State Road, PO Box 1424, Ashtabula, OH 44005-1424 at a cost of \$69,075.00 (minus trade-in of \$1,000.00 for a 2002 Spectec, 75 cubic yard transfer trailer) in totaling a cost not to exceed Sixty-Eight Thousand Seventy-Five Dollars and 00/100 (\$68,075.00).

SECTION 2. That \$68,075.00 shall be paid from the Equipment Purchase Fund – Tractor and/or Trailer account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to replace equipment that is out of service (replacing a 2002, 75 cubic yard transfer trailer) and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
