AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE ONE (1) 2019 JEEP CHEROKEE FOR THE MAYOR UNDER THE STATE COOPERATIVE PURCHASING ACT FROM VISION AUTOMOTIVE, LLC, AT A COST NOT TO EXCEED \$26,234.74

WHEREAS: Council passed Resolution 20-88 on March 21, 1988 authorizing the Administration to participate in the Ohio Cooperative Purchasing Act; and,

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to purchase one (1) 2019 Jeep Cherokee for the Mayor from Vision Automotive, LLC, under the State Cooperative Purchasing Act, under which the State of Ohio publicly bids vehicles for governmental use annually, as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River is hereby authorized to purchase one (1) 2019 Jeep Cherokee vehicle at a cost not to exceed Twenty-Six Thousand Two Hundred Thirty-Four Dollars and 74/100 (\$26,234.74), from Vision Automotive, LLC, 20390 County Road 424, Defiance, Ohio 43512 under the Ohio Cooperative Purchasing Act.

SECTION 2. That \$26,234.74 for one (1) vehicle shall be paid for from the Equipment Purchase Fund – Vehicle Purchase Account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and to participate timely in the Ohio Cooperative Purchasing program, at the State's prevailing price and for the further reason that it is necessary to update the vehicle fleet, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor: otherwise it shall take effect and be in force from and after the earliest period allowed by law.
