AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO RENEW A CONTRACT FOR ONE (1) YEAR FOR THE PURCHASE OF JANITORIAL SUPPLIES FOR THE CITY OF ROCKY RIVER FROM OHIO VALLEY SUPPLY AND MAINTENANCE CO. AT A COST NOT TO EXCEED \$55,000.00

WHEREAS: in 2015, the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of janitorial supplies and five (5) bids were received; after review by the Director of Public Safety-Service, it was deemed to be in the best interest of the City of Rocky River to accept the lowest and best bid for janitorial supplies from Ohio Valley Supply and Maintenance Co., at a cost not to exceed \$55,000.00.

WHEREAS: pursuant to ordinance 43-15 City Council adopted the acceptance of the bid for janitorial supplies from Ohio Valley Supply and Maintenance Co., 2011 St. Clair Ave N.E., Cleveland, Ohio 44114-4047, to renew for an additional one year. In Ordinance 21-16 City Council authorized a renewal at the same cost. City Council now determines that it is in the best interest of the City to renew the terms and conditions of this bid for an additional one (1) year period.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River be authorized to contract for janitorial supplies from Ohio Valley Supply and Maintenance Co., 2011 St. Clair Ave N.E., Cleveland, Ohio 44114-4047, for the option year of 2019 in an amount not to exceed Fifty Five Thousand Dollars and 00/100 (\$55,000.00).

SECTION 2. That janitorial supplies shall be charged to the following funds: General, Recreation Center, Waste Water Treatment Plant Utility, Senior Center, Marine Patrol, Refuse & Recycling, Sanitary Sewer and Street Construction Maintenance & Repair, which funds are already appropriated.
