

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO RENEW AN AGREEMENT WITH RUMPKE OF NORTHERN OHIO, INC., FOR THE REMOVAL OF RAW SEWAGE SLUDGE FROM THE WASTEWATER TREATMENT PLANT AT A COST OF \$42.10 PER TON FOR 2019 AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: in 2016 the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that allow annual renewals for the removal of raw sewage sludge from the Wastewater Treatment Plant; and

WHEREAS: two (2) bids were received and reviewed by the Wastewater Treatment Plant Superintendent, it was determined to accept the lowest and best bid for removal of raw sewage sludge from Rumpke of Northern Ohio, Inc., copies of said bids are on file in the office of the Director of Public Safety-Service; and

WHEREAS: pursuant to Ordinance 64-16 City Council has determined that it is in the best interest of the City of Rocky River to accept the lowest and best bid for removal of raw sewage sludge from Rumpke of Northern Ohio, Inc., for a period of one year at a cost of \$42.10 per ton; and

WHEREAS: City Council has determined that it is in the best interest of the City of Rocky River to authorizing the renewal of the agreement for the removal of raw sewage sludge from Rumpke of Northern Ohio, Inc. for one (1) additional period of one year at a cost of \$42.10 per ton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of raw sewage sludge for one year with renewal on an annual basis from Rumpke of Northern Ohio, Inc., 10795 Hughes Road, Cincinnati, Ohio 45251 at the price of \$42.10 per ton.

SECTION 2. That funds for the removal of raw sewage sludge shall be paid from the Wastewater Treatment Plant Utility Fund.

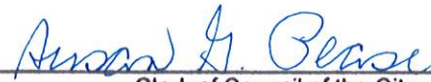
