AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO RENEW AN AGREEMENT WITH RUMPKE OF NORTHERN OHIO, INC., TO PURCHASE SERVICES FOR THE REMOVAL OF GRIT AND SCREENINGS FOR THE WASTEWATER TREATMENT PLANT AT \$65.00 PER TON FOR 2019 AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: in 2016 the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that allow annual renewals for the removal of grit and screenings for the Wastewater Treatment Plant;

WHEREAS: two (2) bids were received and reviewed by the Wastewater Treatment Plant Superintendent, it was determined to accept the lowest and best bid for the removal of grit and screenings from Rumpke of Northern Ohio, Inc., copy of said bids are on file in the office of the Director of Public Safety-Service; and

WHEREAS: pursuant to Ordinance 65-16 City Council has determined that it is in the best interest of the City of Rocky River to accept the lowest and best bid for the removal of grit and screenings from Rumpke of Northern Ohio, Inc., with renewals for additional one year periods, at \$65.00 per ton; and

WHEREAS: City Council has determined that it in the best interest of the City of Rocky River to authorize renewal of the agreement for one (1) additional year for the removal of grit and screenings from Rumpke of Northern Ohio, Inc. at \$65.00 per ton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of grit and screenings for one (1) year with renewal available on an annual basis from Rumpke of Northern Ohio, Inc., 10795 Hughes Road, Cincinnati, Ohio 45251 at \$65.00 per ton.

SECTION 2. That funds for the removal of grit and screenings shall be paid from the Wastewater Treatment Plant Utility Fund.
