ORDINANCE NO. 59-18

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO RENEW AN AGREEMENT WITH RUMPKE OF NORTHERN OHIO, INC., FOR A PERIOD OF ONE YEAR FOR THE REMOVAL OF DIGESTED SLUDGE CAKE TO A MUNICIPAL LANDFILL FOR THE WASTEWATER TREATMENT PLANT AT A COST OF \$42.10 PER TON AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: in 2016 the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that allow renewal on annual basis for the removal of digested sludge cake to a landfill from the Wastewater Treatment Plant; and

WHEREAS: three (3) bids were received and upon review by the Waste Water Treatment Plant Supervisor, it was determined to accept the lowest and best bid for the removal of digested sludge cake to a landfill from the Wastewater Treatment Plant from Rumpke of Northern Ohio, Inc., for a period of one (1) year, copies of bids are on file in the office of the Director of Public Safety Service; and

WHEREAS: pursuant to Ordinance 63-16 City Council has determined that it is in the best interest of the City of Rocky River accept the bid for the removal of digested sludge cake to a landfill from Rumpke of Northern Ohio, Inc. bid with renewals for additional one year periods at cost of \$42.10 per ton; and

WHEREAS: City Council has determined that it is in the best interest of the City of Rocky River to authorize renewal of the agreement for the removal of digested sludge cake to a landfill with Rumpke of Northern Ohio, Inc. bid for a period of one (1) additional year at a cost of \$42.10 per ton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of digested sludge cake to a municipal landfill for a period of one year, with renewal available on an annual basis from Rumpke of Northern Ohio, Inc., 10795 Hughes Road, Cincinnati, Ohio 45251 at the cost of \$42.10 per ton.

SECTION 2. That funds for the removal of digested sludge cake to a municipal landfill shall be paid from the Wastewater Treatment Plant Utility Fund.

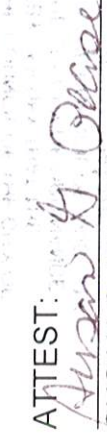
