AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND/OR THE SAFETY-SERVICE DIRECTOR TO PURCHASE ONE (1) 2018 FREIGHTLINER REFUSE PACKER CHASSIS FOR THE SERVICE DIVISION UNDER THE OHIO DEPARTMENT OF TRANSPORTATION'S COOPERATIVE PURCHASING ACT FROM VALLEY FREIGHTLINER, INC., AT A COST NOT TO EXCEED \$100,371.00

WHEREAS: Council passed Resolution 81-13 authorizing the Administration to participate in the ODOT Cooperative Purchasing Program; and,

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to purchase one (1) 2018 Freightliner Refuse Packer Chassis for the Service Division under the State Cooperative Purchasing Act, which publicly bids vehicles, from Valley Freightliner, Inc., 10901 Brookpark Road, Parma, OH 44130 as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA STATE OF OHIO:

SECTION 1. That the Mayor and/or the Safety-Service Director of the City of Rocky River is hereby authorized to purchase one (1) 2018 Freightliner Refuse Packer Chassis at a cost not to exceed One Hundred Thousand Three Hundred and Seventy-One Dollars and 00/100 (\$100,371.00) from Valley Freightliner, Inc., under the Ohio Cooperative Purchasing Act.

SECTION 2. That \$100,371.00 for one (1) 2018 Freightliner Refuse Packer Chassis shall be paid for from the Refuse Packer(s) account of the Equipment Purchase Fund.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and to participate timely in the Ohio Department of Transportation Purchasing program, at the State's prevailing price and for the further reason that it is necessary for the Service Division, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
