AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE SODIUM BISULFITE FOR THE WASTEWATER TREATMENT PLANT FROM PVS CHEMICAL SOLUTIONS, INC. AT \$1.26 PER GALLON FOR THE YEAR 2019

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the purchase of sodium bisulfite for the Wastewater Treatment Plant; and

WHEREAS: four (4) bids were received on October 12, 2018 for sodium bisulfite, copies of which are on file in the office of the Director of Public Safety-Service.

WHEREAS: the Director of Public Safety-Service and Waste Water Treatment Plant Supervisor have determined the lowest and best bid for sodium bisulfite to be from PVS Chemical Solutions, Inc., 10900 Harper Avenue, Detroit, MI 48213.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase sodium bisulfite for one (1) year with an option to renew on an annual basis from PVS Chemical Solutions, Inc., 10900 Harper Avenue, Detroit, MI 48213 at \$1.26 per gallon.

SECTION 2. That funds for the purchase of sodium bisulfite shall be paid from the Wastewater Treatment Plant Utility Fund.
