AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE SODIUM HYPOCHLORITE FOR THE WASTEWATER TREATMENT PLANT FROM BONDED CHEMICALS, INC. AT \$0.769 PER GALLON FOR 2019

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the purchase of sodium hypochlorite for the Wastewater Treatment Plant; and

WHEREAS: on October 12, 2018, three (3) bids for sodium hypochlorite were received, and reviewed by the Wastewater Treatment Plant Superintendent, copy of said bid is on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service and Wastewater Treatment Plant Superintendent have determined it to be in the best interest of the City and the Wastewater Treatment Plant to accept the bid with the option to renew on an annual basis from Bonded Chemicals, Inc.; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase sodium hypochlorite from Bonded Chemicals, Inc., 2645 Charter Street, Columbus, Ohio 43228 at \$0.769 per gallon.

SECTION 2. That funds for the purchase of sodium hypochlorite shall be paid from the Wastewater Treatment Plant Utility Fund.
