ORDINANCE NO. 76-18

AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT FOR VARIOUS INSURANCE COVERAGES FOR THE ROCKY RIVER MUNICIPAL COURT WITH JACKSON DIEKEN & ASSOCIATES FOR THE YEAR 2019 AT A TOTAL COST OF \$9,828.00

WHEREAS: the Director of Safety-Service advertised for proposals for the purchase of various insurance coverages for the Rocky River Municipal Court which allows annual renewals; and

WHEREAS: one (1) proposal was received for purchase of various insurance coverages for the Rocky River Municipal Court, copy of which is available for inspection in the office of the Director of Public Safety-Service; and

WHEREAS: the Mayor and Director of Public Safety-Service have determined it is the best interest of the City of Rocky River to accept the proposal for insurance coverages for the Rocky River Municipal Court from Jackson Dieken & Associates, 27893 Clemens Road, Westlake, Ohio 44145.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor and Director of Public Safety-Service of the City of Rocky River are hereby authorized to enter into an agreement for insurance coverage which allows annual renewals, and said coverage for the Municipal Court will include Property Insurance, Public Officials and Employees Liability, Blanket Position Bonds, Clerk of Court Bond, Blanket Bond/ Crime, Law Enforcement Liability, EDP / Property Floater, Valuable Papers and Business Auto Liability for the Rocky River Municipal Court facility for a cost of NINE THOUSAND EIGHT HUNDRED TWENTY-EIGHT AND 00/100 DOLLARS (\$9,828.00) through Jackson Dieken & Associates, insurance agents and Houston Casualty Group, HCC Insurance Holdings, Inc. Insurance Company (as underwritten by the US Specialty Insurance Company).

SECTION 2. That the net cost of the purchase of this insurance shall be appropriated and paid from the General Fund: Judges - Insurance and Court- Insurance.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and for the further reason that the current policy items will expire on January 1, 2019, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
