ORDINANCE NO. 77-18

AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT FOR VARIOUS INSURANCE COVERAGES FOR THE ROCKY RIVER WASTEWATER TREATMENT PLANT WITH MCGOWAN INSURANCE COMPANY, INC. FOR THE YEAR 2019 AT A TOTAL COST OF \$76,922.00

WHEREAS: the Director of Safety-Service advertised for proposals for the purchase of various insurance coverages for the Rocky River Wastewater Treatment Plant which allows annual renewals; and,

WHEREAS: one (1) proposal was received for the purchase of various insurance coverages for the Rocky River Wastewater Treatment Plant, copy of which is available for inspection in the office of the Director of Public Safety-Service; and

WHEREAS: the Mayor and Director of Public Safety-Service have determined it is the best interest of the City of Rocky River to accept the proposal for insurance coverages for the Rocky River Wastewater Treatment Plant from McGowan Insurance, 20595 Lorain Rd., Fairview Park, Ohio 44126.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor and Director of Public Safety-Service for the City of Rocky River are hereby authorized to enter into an agreement for insurance coverage which allows annual renewals, and said coverage for the Wastewater Treatment Plant will include Buildings and Contents, Extra Expense, Valuable Papers, Equipment Floater, General Liability, Boilers and Machinery Insurance and Umbrella Liability, Public Officials Liability, Terrorism, Property in Open Insurance, Automobile Liability and Cyber Attack Coverage for the Rocky River Wastewater Treatment Plant at a cost of SEVENTY-SIX THOUSAND NINE HUNDRED AND TWENTY-TWO (\$76,922.00) through MCGOWAN AND COMPANY, INC. insurance agents and as underwritten by Liberty Mutual Insurance Company.

SECTION 2. That the net cost of the purchase of this insurance shall be appropriated and paid from the Wastewater Treatment Plant Utility Fund.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and for the further reason that the current policy items will expire on January 1, 2019, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
