ORDINANCE NO. 79-18

AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE A 2018 CATCH BASIN/VACUUM TRUCK UNIT WITH 16 CUBIC YARD BODY FOR THE SERVICE DIVISION FROM BEST EQUIPMENT AT A TOTAL COST NOT TO EXCEED \$174,640.00.

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) 2018 Catch Basin/Vacuum Truck unit with 16 Cubic Yard Body for the City of Rocky River Service Division; and

WHEREAS: one (1) bid was received for a 2018 Catch Basin/Vacuum Truck unit with 16 Cubic Yard Body, a copy of which is on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to select this bid for a 2018 Catch Basin/Vacuum Truck unit with 16 Cubic Yard Body, for the Service Division from Best Equipment, 12620 York Delta Drive, North Royalton, OH 44133.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River is hereby authorized to purchase a 2018 Catch Basin/Vacuum Truck unit with 16 Cubic Yard Body at a total cost not to exceed One Hundred and Seventy-Four Thousand Six Hundred and Forty Dollars and 00/100 (\$174,640.00) from Best Equipment.

SECTION 2. That \$174,640.00 for a 2018 Catch Basin/Vacuum Truck unit with 16 Cubic Yard Body shall be paid for from the Equipment Purchase Fund – Vehicle Purchase account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to update the Service Division vehicle fleet and to coordinate this equipment's installation onto the chassis, and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
