AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND/OR THE SAFETY-SERVICE DIRECTOR TO PURCHASE SIX (6) CONTROLLER UNITS AND FOUR (4) GPS UNITS FOR THE SERVICE DIVISION UNDER THE OHIO DEPARTMENT OF TRANSPORTATION'S COOPERATIVE PURCHASING CONTRACT FROM BALDWIN & SOURS, INC. AT A COST NOT TO EXCEED \$17,530.00

WHEREAS: Council passed Resolution 81-13 authorizing the Administration to participate in the ODOT Cooperative Purchasing Program; and,

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to purchase six (6) controller units and four (4) GPS units for the Service Division under the State Cooperative Purchasing Act, which publicly bids equipment parts, from Baldwin & Sours, Inc. 5263 Trabue Road, Columbus, OH 43228 as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA STATE OF OHIO:

SECTION 1. That the Mayor and/or the Safety-Service Director of the City of Rocky River is hereby authorized to purchase (6) controller units and four (4) GPS units for the Service Division at a cost not to exceed Seventeen Thousand Five Hundred and Thirty Dollars and 00/100 (\$17,530.00) from Baldwin & Sours, Inc. under the Ohio Cooperative Purchasing Act.

SECTION 2. That \$17,530.00 for six (6) controller units and four (4) GPS units shall be paid for from the Municipal Motor Vehicle Fund T S Upgrade Account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and to participate timely in the Ohio Department of Transportation Purchasing program, at the State's prevailing price and for the further reason that it is necessary for the Service Division, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
