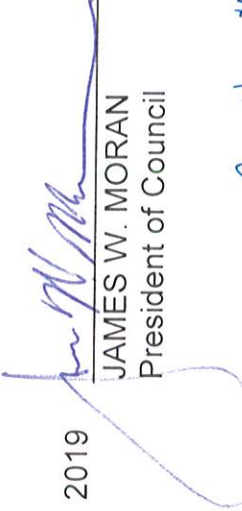
WHEREAS: the fees for the Rocky River Ice Skating Rink have not been revised since 2015;
