A RESOLUTION ACCEPTING AMOUNTS AND RATES
AS DETERMINED BY THE CUYAHOGA COUNTY BUDGET COMMISSION AND
AUTHORIZING THE NECESSARY TAX LEVIES AND
CERTIFYING THEM TO THE CUYAHOGA COUNTY FISCAL OFFICER AS FURTHER
DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: The City Council, City of Rocky River, Ohio (City) in accordance with the general laws of the State of Ohio, with the passage of Resolution No. 46-19 accepted the Alternative Tax Budget Information for the fiscal year commencing January 1, 2020; and

WHEREAS: The Budget Commission of Cuyahoga County, Ohio, has certified its action thereon to this Council, together with an estimate by the Cuyahoga County Fiscal Officer of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part thereof is within the ten mill tax limitation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. - That the amounts and rates, as determined by the Budget Commission of Cuyahoga County, Ohio, in its certification, be and the same are hereby accepted.

SECTION 2. - That there be and is hereby levied on the tax duplicate of said City, the rate of each tax necessary to be levied within and without the ten mill limitation, as set forth below and in Schedule A of the attached Exhibit "A", which is a continuation of Section 2 of this Resolution.
