RESOLUTION NO. 61-19

AN EMERGENCY RESOLUTION SUPPORTING THE ESTABLISHMENT OF THE LAKE
ERIE WATER TRAIL AS DESCRIBED IN EXHIBIT A.

WHEREAS, Cuyahoga County lakefront communities and Cleveland Metroparks propose the establishment of the Lake Erie Water Trail in Cuyahoga County as a means to improve access for outdoor recreation and to encourage tourism and educational, historical, cultural, eco-friendly activities on Lake Erie; and

WHEREAS, The Cleveland Metroparks has recommended Bradstreet's Landing Park as a designated point of interest on the proposed Lake Erie Waterfront Trail.

WHEREAS, said Water Trail designation must meet the criteria and guidelines for approval by the Ohio Department of Natural Resources, attached Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. The City of Rocky River of County of Cuyahoga, Ohio declares its support for the establishment of the Lake Erie Water Trail in Cuyahoga County as a means to encourage tourism, educational, historical, cultural, recreational, and eco-friendly activities on Lake Erie

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 3: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and is necessary to participate in the program provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
