A RESOLUTION REQUESTING THE CUYAHOGA COUNTY FISCAL OFFICER TO
ADVANCE TAXES HELD FROM THE PROCEEDS OF SPECIAL ASSESSMENTS FOR
THE TAX YEAR 2019 PURSUANT TO THE OHIO REVISED CODE

WHEREAS: Ohio Revised Code Section 321.34 provides that any money held in the Cuyahoga County Treasury paid to the accounts of the City of Rocky River, Ohio and lawfully applicable to the budgetary purpose of the current fiscal year, may be drawn by request; and

WHEREAS: Such provision will provide for effective and efficient cash management of the City by providing special assessment revenue to be distributed by the Cuyahoga County Fiscal Officer to the City in advance of the close of the tax collection and settlement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1 – That the Fiscal Officer of Cuyahoga County be and he is hereby requested to draw his warrants, and the Treasurer of said County be and he is hereby requested to advance on special assessment funds and to pay over to the Director of Finance of the City any money in the Cuyahoga County Treasury to the account of said City and lawfully applicable to the purposes of the current fiscal year of the assessment funds listed in Section 2 below.

SECTION 2 – That the assigned fund numbers of the advances requested are as follows:
