ORDINANCE NO. 74-19

AN EMERGENCY ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO PURCHASE A 25 CUBIC YARD TRAILER MOUNTED SELF-CONTAINED VACUUM LEAF COLLECTOR FOR THE SERVICE DIVISION FROM BEST EQUIPMENT AT A TOTAL COST NOT TO EXCEED \$74,190.00.

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) 25 Cubic Yard Trailer Mounted Self-Contained Vacuum Leaf Collector for the City of Rocky River Service Division; and

WHEREAS: one (1) bid was received for a 25 Cubic Yard Trailer Mounted Self-Contained Vacuum Leaf Collector, a copy of which is on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to select the bid for a 25 Cubic Yard Trailer Mounted Self-Contained Vacuum Leaf Collector, for the Service Division from Best Equipment, 12620 York Delta Drive, North Royalton, OH 44133.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety-Service Director of the City of Rocky River is hereby authorized to purchase a 25 Cubic Yard Trailer Mounted Self-Contained Vacuum Leaf Collector from Best Equipment at a total cost not to exceed Seventy-Four Thousand One-Hundred and Ninety Dollars and 00/100 (\$74,190.00).

SECTION 2. That \$74,190.00 for a 25 Cubic Yard Trailer Mounted Self-Contained Vacuum Leaf Collector shall be paid for from the Equipment Purchase Fund – Equipment Streets, Vehicles and Large Equipment Purchases Account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to update the Service Division vehicle fleet, and to minimize the further delay for delivery, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
