AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE FERRIC CHLORIDE FOR THE WASTEWATER TREATMENT PLANT FROM PVS TECHNOLOGIES, INC., AT \$558.00 PER DRY TON FOR 2019

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the purchase of ferric chloride for the Wastewater Treatment Plant; and

WHEREAS: two (2) bids were received on October 12, 2019 for ferric chloride, copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety-Service and Waste Water Treatment Plant Supervisor have determined that it is in the best interest of the City to accept the lowest and best bid for ferric chloride from PVS Technologies, Inc., 10900 Harper Avenue, Detroit, MI 48213.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase ferric chloride for one (1) year with an option to renew for one (1) year on an annual basis from PVS Technologies, Inc., 10900 Harper Avenue, Detroit, MI 48213 at \$558.00 per dry ton.

SECTION 2. That funds for the purchase of ferric chloride shall be paid from the Wastewater Treatment Plant Utility Fund.
