AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH ABC PIPING COMPANY FOR FIRE SUPPRESSION FOR THE POLICE STATION FOR THE CITY OF ROCKY RIVER IN AN AMOUNT NOT TO EXCEED \$149,500.00

WHEREAS: the Director of Public Safety-Service of the City of Rocky advertised for bids for Fire Suppression for the Police Station; and

WHEREAS: Four (4) bids were received on September 6, 2019 as set forth in the attached Exhibit "A" copies of which are on file in the office of the Director of Public Safety-Service; and

WHEREAS: the consulting engineering firm Bowen & Associates, recommends that the lowest and best bid from ABC Piping Company be accepted at a cost not to exceed One Hundred Forty Two Thousand Dollars and 00/100 (\$142,000.00) with a contingency of 5.28% in the amount of Seven Thousand Five Hundred Dollars (\$7,500.00) for an overall total of One Hundred Forty Nine Thousand Five Hundred Dollars (\$149,500.00).

WHEREAS: based on the recommendation of Bowen & Associates, the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to consider the award of the Fire Suppression contract to be an emergency and to select the lowest and best bid from ABC Piping Company as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor of the City of Rocky River is hereby authorized to enter into agreement with ABC Piping Company, 1277 East Schaaf Road #5, Cleveland, OH 44131 in an amount not to exceed One Hundred Forty Nine Thousand Five Hundred Dollars and 00/100 (\$149,500.00) as described in Exhibit "A".

SECTION 2. That funds for the payment of said services shall be paid from the Building account of the Capital Improvement Fund.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to build a new police station provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

 Recommendation of Prime Contractor for Bid Package #4 – Fire Suppression

Dear Director Snyder,

Please consider this correspondence as our formal recommendation to award the Prime Contract for Bid Package #4 – Fire Suppression to **ABC Piping Company** for the New Rocky River Police Station project.

The total contract amount recommended above is composed of the following:

Base Bid Package #4 – Fire Suppression	\$	117,000.00
Alternate #1 – Vehicle Garage (Equivalent to former Alternate #5)	\$	15,000.00
Alternate #2 – Firing Range Cold Dark Shell (Equivalent to former Alternate #1A)	\$	10,000.00
Contingency	\$	7,500.00
Total Contract Value	\$	149,500.00

Our recommendation is based on the following:

- Four (4) bids were received on Friday, September 6, 2019, for Bid Package #4 – Fire Suppression. Of the bids received, ABC Piping Company submitted the lowest Base Bid amount. The next lowest bidder's proposed Base Bid amount exceeded ABC Piping's bid by \$51,800.00.
- ABC Piping's bid submission included all required documents.
- ABC Piping's Base Bid amount is below the published estimate (\$145,570.00) for Bid Package #4 – Fire Suppression.
- ABC Piping's submitted bids for Alternates #1 – Vehicle Garage, Alternate #2 – Firing Range Cold Dark Shell, and Alternate #3 – Firing Range Interior Fit-Out are also below the estimates for each alternate.
- On Tuesday, January 14, 2020, the project Mechanical Engineer, John Milenius, PE, (TEC, Inc.) completed a scope review with representatives from ABC Piping. ABC Piping representatives included Dino Campellone, Project Manager. Documentation from Mr. Milenius recording this session is attached.

6. During the scope review, ABC Piping Co. demonstrated a clear understanding of the requirements of this project and alternates. They verbally acknowledged that they received the full set of bid documents (plans, specs, and addenda), including the proposed construction schedule, and took no exceptions.
