AN EMERGENCY RESOLUTION APPOINTING THE CHARTER REVIEW  
COMMISSION AS PROVIDED IN ARTICLE X, SECTION 4 OF THE CHARTER OF  
THE CITY OF ROCKY RIVER, OHIO

WHEREAS: The Charter of the City of Rocky River, Ohio, under Article X, Section 4,  
entitle Charter Review, provides that in January 1984 and each six (6) years thereafter the  
Council shall appoint nine (9) electors of the City as members of a Charter Review  
Commission; and

WHEREAS: This Council is prepared to make such appointment.

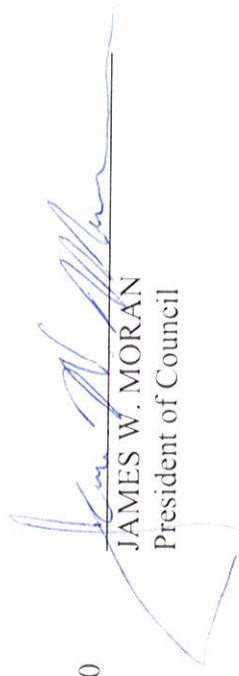
NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY  
RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. – That the following electors of the City of Rocky River are hereby appointed to

SECTION 2. – That this Resolution is hereby declared to be an emergency measure,  
necessary for the immediate preservation of public peace, health and safety, and for the  
further reason that such appointments must be legislatively enacted immediately so that the  
Commission can begin its task, and provided it receives the affirmative vote of two-thirds  
(2/3) of all members elected to Council, it shall take effect and be in force immediately upon  
its passage and approval by the Mayor; otherwise it shall take effect and be in force from and  
after the earliest period allowed by law.

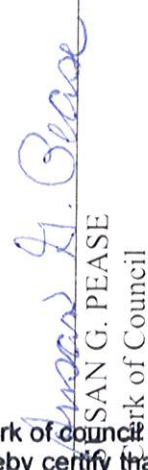
