AN ORDINANCE AUTHORIZING THE MAYOR AND THE SAFETY SERVICE DIRECTOR TO RENEW AN AGREEMENT WITH FABRIZI TRUCKING & PAVING CO., INC. FOR THE EMERGENCY REPAIR OF STREETS AND STORM AND SANITARY SEWERS WITHIN THE CITY OF ROCKY RIVER AT A COST NOT TO EXCEED \$125,000.00 AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: the Safety Service Director of the City of Rocky River advertised for bids for the emergency repair of streets and storm and sanitary sewers within the City of Rocky River in February of 2011 and (1) bid was received on March 4, 2011 from Fabrizio Trucking & Paving Co, a copy of which is on file in the office of the Director of Public Safety-Service; and

WHEREAS: In Ordinance 10-11 City Council had determined that it was in the best interest of the City of Rocky River to accept the bid and enter into a contract with Fabrizio Trucking & Paving Co. for emergency repair of streets and storm and sanitary sewers and in Ordinance 1-18 City Council accepted the renewal of the agreement for said repairs with Fabrizio Trucking & Paving Co., Inc.

WHEREAS: Due to infrastructure conditions that were undetectable, emergency sewer and street repairs have caused the need to extend the agreement with Fabrizio Trucking and Paving for 2020 at the same costs and not to exceed One Hundred and Twenty-Five Thousand and 00/100 Dollars (\$125,000.00).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor and the Safety-Service Director are hereby authorized to enter into an agreement with Fabrizio Trucking & Paving Co., Inc., 20389 First Avenue, Middleburg Hts., OH, 44130, for the emergency repair of streets and storm and sanitary sewers for 2020 at a total net cost not to exceed One Hundred and Twenty-Five Thousand and 00/100 Dollars (\$125,000.00) with prices for said service further described in Exhibit "A".

SECTION 2. That funds for the payment of said services shall be paid from the Capital Improvement Fund-Emergency Sewer Repair Account.
